#### DIVORCE PROCESS BASICS

- <u>Filing of Complaint for Divorce</u> A Complaint for Divorce is filed with the Circuit Court by one of the two people who are married the person who files the Complaint is the Plaintiff the other person is the Defendant (note the Plaintiff and Defendant are each a party to the divorce case). The Plaintiff may hire an attorney or file without an attorney. If you do not have an attorney you are **In Pro Per** which just means you are representing yourself.
- <u>Service of Complaint</u> Complaint for Divorce is served on the Defendant by the Plaintiff the Defendant will then either file an answer or counter-complaint on their own or with the help of an attorney, or in some cases not file a response. If no response is filed by the Defendant a Default Judgment of Divorce could be entered.
- <u>Temporary Orders</u> there may be temporary orders entered while the divorce is in process about payment of bills, custody, parenting time, and child support.
- <u>Negotiate A Settlement</u> the Plaintiff and Defendant (the parties on the case) then need to work out: custody and parenting time, child support, and division of marital property and marital financial obligations (payment of debts) this agreement will then be written up in an order called a Judgment of Divorce.
- <u>Divorce Trial, Mediation, or Arbitration</u> if the parties can not work out an agreement their case could be referred for Mediation or Arbitration or could have a Divorce Trial before the Judge to determine issues parties disagree about.
- Entry of Judgment of Divorce and Uniform Child Support Order once all the issues have been worked out a court order called a Judgment of Divorce will be entered and if there is child support, medical support, or health care coverage ordered a Uniform Child Support Order will also be entered.
- <u>Pre-Judgment and Post-Judgment</u> Friend of the Court does some things to help the Court before the Judgment of
  Divorce is entered this time period is called pre-judgment and some things after the Judgment of Divorce is entered –
  this time period is called post-judgment. Support and Custody Investigations, Motions, Enforcement, and Information.



#### CHILD SUPPORT 101

- Your first contact with FOC will likely be with a Support Investigator
- You MUST attend this appointment, even if you plan to opt out of FOC services
  - During COVID 19→ Appointment is being conducted via phone/zoom
- Remember → You are only eligible to opt out if there is NO public assistance for any parties
- Information will be gathered to issue a Final Support Recommendation on child support.
- Child support is calculated using the Michigan Child Support Formula
  - Looks at both parties' incomes, average number of overnights per parent, health insurance premiums, day care expenses, and other factors that may affect support
- The investigator may issue two recommendations if custody/parenting time is in dispute



## POST JUDGMENT MODIFICATION OF SUPPORT

- You are entitled to a support every 3 years via a written request to the FOC
- You may file a motion to modify support at any time if there is a change in circumstances
- The FOC may petition the Court for a review of support in any of the following circumstances:
  - You become the recipient of SSD or SSI benefits
  - You become the recipient of VA benefits
  - You are unemployed and collecting unemployment benefits
  - You have a workers compensation claim or are receiving PIP benefits
  - One of the parties is incarcerated for an extended period of time



#### CUSTODY INVESTIGATIONS

- FOC currently has 5 custody investigators
- If custody is disputed, your case may be referred to the Custody Dep. of FOC
- There is a \$500 fee for this that may be charged fully, partially, or waived.
- The investigator will interview the parties involved and any witnesses
  - Children over the age of 4 MAY be interviewed
  - Home inspections MAY be conducted
- A report and recommendation is issued following the Michigan Child Custody Act



#### ENFORCEMENT OF COURT ORDER

- Post Judgment, the FOC will enforce the child support, spousal support, medical, custody, and parenting time provisions of the Order.
- FOC can ONLY enforce the Order signed by the Judge, no outside agreements or deviations that are not in the Order
- A Judicial Service Officer (JSO) is assigned to each case. Each Judge has 2 JSO's for support, 1 JSO for parenting time, 1 Medical Support Specialist
- You must keep FOC updated on any changes in address or employment/unemployment



#### CHILD SUPPORT COLLECTION

- Most common method of collecting support → Income Withholding Order to Employer
  - This garnishes child support via payroll and is sent to the MISDU for payment processing
- If you are self employed you must pay on your own.

#### CHILD SUPPORT ENFORCEMENT

- Show Cause Hearing
  - Conducted by the JSO for non payment of support. Gives the payer an opportunity to explain their circumstances for non payment to the JSO
    - If no resolution is reached → hearing may advance with the Judge where you may be found in contempt
  - Failure to appear at these hearings may result in a bench warrant for the non payer's arrest.
- Passport holds for any arrearage over \$2,500.00
- Bank Levy: Bank account may be frozen and intercepted for nonpayment of support
- Interception of tax refunds
- Credit reporting: If non payer is at least 2 months in arrears
- License restrictions
- Should the payer of support move to another state, FOC may be able to initiate enforcement of our court order by the other state.

#### MEDICAL ENFORCEMENT

- Each Uniform Child Support Order has provisions that order one or both parties to maintain insurance for the benefit of the child
- Requires the non custodial parent to pay each month towards the ordinary medical amount to help cover health care expenses incurred on behalf of the child(ren).
  - Once the custodial parent has incurred all the costs of the annual ordinary medical amount, the Order will indicate a percentage split that each party is responsible for.
- Uninsured health care expenses include:
  - Insurance co-pays, deductibles, orthodontic treatment, and other uninsured health care costs
- A parent may submit a request to FOC for proportionate reimbursement for the amount the other parent has not paid.



#### PARENTING TIME ENFORCEMENT

- Denials of parenting time
  - FOC cannot force a parent to exercise his or her parenting time; however, a parent may
     NOT deny parenting time to the parent trying to exercise per their court order
  - Denials of parenting time require the parent to actually attempt to pick up the child(ren)
- Failure to return the child(ren) to the custodial parent
- Change of domicile violation (example: moving out of state)
- Excessive tardiness for parenting time exchanges
- Joint legal custody violations
  - Change in child's school district, doctor/medical/professional appointments/consultations without the other parent's knowledge or consent



#### PARENTING TIME REMEDIES

- Most common → 21 Day Letters from the JSO
  - Letter advising parent A that parent B was denied parenting time. The letter also advises parent A to offer make up parenting time to the parent who was denied his or her parenting time
- Joint meetings
  - A meeting scheduled by FOC in an attempt to reach an agreement on a parenting time issue or a resolution on an ongoing parenting time issue.
  - At the conclusion of this meeting, a consent order may be entered.
- Show Cause Hearing
  - A contempt hearing held by the JSO which may or may not be heard in front of the Judge
    - Contempt sanctions include make up parenting time, a change in the order, and/or incarceration



## NON ENFORCEABLE PARENTING TIME ISSUES

- Extracurricular activities or sporting activities
- Communication issues
  - Includes phone calls, texts, facetime, Our Family Wizard app, etc
- Parental Cooperation Orders
- Child(ren)'s belongings
  - Clothing, electronics, toys, etc
  - It is expected that both parents have essential items on them for the duration of the child(ren)'s stay with that parent.
    - Clothing, baby formula, diapers, etc
- Remember → Just because FOC may not enforce something in your order, does not mean it is a lost cause, you may file motion with the Court

A referee is a quasi-judicial court officer who is assigned to a Judge and hears motions and conducts evidentiary hearings for that Judge.

 After a hearing, the Referee will make a written recommendation that typically becomes an order unless an objection is filed. Objections are heard by the Judge.
