Municipal Offices, 47275 Sugarbush, Chesterfield, MI.
- 2. Litigants may decline to participate and may request that their cases be heard in the courthouse proper.
- 3. These off-site sessions will be open to the public.
- 4. Prior to the court holding sessions outside their normal location, the court will have a written plan that shall include information about the off-site location including:
