

Within our three divisions; Children and Family Services, Community Services and Office of Senior Services, our team of committed and compassionate professionals work relentlessly to ensure our clients are given immediate assistance, along with short and long-term solutions, to help increase their quality of life.

2017-2018 HIGHLIGHTS

NEW KIOSKS INSTALLED AT THE FAMILY RESOURCE CENTERS

Through a United Way for Southeastern Michigan grant, informational kiosks were installed at the Macomb County Family Resource Center and the Max Thompson Family Resource Center to make services more accessible. The kiosks contain information on agencies and services in each building, as well as, building and community events. The kiosks also provide access to online appointment scheduling for Community Action Center services. Staff presented this project model at the Michigan Community Action statewide conference in July 2018.



RESOURCE FAIR

A Health and Community Resource Fair was held at the Macomb County Family Resource Center, Co-Sponsored by Head Start 0-5 and Community Development Programs.



Over 250 children and their families were offered wellness screenings and a chance to meet their teachers for the upcoming school year.

25 county partners and organizations offered resource tables including the Macomb Food Program Fresh Mobile Pantry.



WALK FOR WARMTH

The 28th annual Walk for Warmth event was held on Saturday, March 3, 2018, at Macomb Mall. Over 160 people participated in the 1-mile competitive run outdoors or the family fun walk indoors. The event raised \$31,444 to assist low-income residents with heat-related emergencies like paying utility bills or replacing a broken furnace. This year, the event had eleven sponsors, which helped to raise funds, as well as, increase visibility in the community. All of the event proceeds will benefit Macomb County residents.

FREE TAX SERVICES

Macomb Community Action partnered with Macomb County Veterans Services and the Accounting Aid Society to open a Volunteer Income Tax Assistance (VITA) site at the Macomb County and Max Thompson Family Resource Centers. Free tax services were offered to residents during the week and on the weekends at various times, based on the site location. Macomb Community Action provided the facility, staffing, and volunteer support, along with appointment scheduling and promotion of services.



The VITA program assists with tax refunds and credits that are commonly accessed by low-income people, ensuring that refunds and credits are maximized.

HEAD START 0-5 GARDENING PROGRAM

Head Start 0-5 in partnership with Michigan State University Extension (MSUE) rolled out a gardening program to help educate pre-school aged children on the importance of eating healthy while exploring new fruits and vegetables. Children were also taught how to take care of their vegetables

and plants while they grow and plant them in the community garden once they're ready. The children planted okra, watermelon, squash, and tomatoes in their garden.
















MACOMB FOOD PROGRAM

ACTION IMPACT

HEAD START 0-5 PROGRAM

Head Start programs promote school readiness of children ages birth to five from low-income families by supporting their development in a comprehensive way. School readiness is foundational across early childhood systems and programs.

Head Start views school readiness as children possessing the skills, knowledge, and attitudes necessary for success in school and for later learning and life. Physical, cognitive, social, and emotional development are all essential ingredients of school readiness. All classrooms/homes use a developmentally appropriate early childhood curriculum called Creative Curriculum that measures child outcomes using Teaching Strategies GOLD, an authentic, ongoing observational system for assessing children from birth through kindergarten.

Head Start provides services to three and four-year-old children through classrooms located in public school buildings, churches, and family resource centers. Early Head Start provides services for infants and toddlers under the age of 3, and pregnant women, through local child care partnerships in homes and centers.

- Oral health and physical wellness for Head Start 0-5 participants
- Mental health and disability Services
- Nutrition education
- Research-based curriculum Creative Curriculum
- Early literacy

- Services for pregnant women



SCHOOL READINESS

The goal of the program is that 100% of enrolled children will show areas of growth in school readiness domains such as social-emotional, physical, language, cognitive, literacy and mathematics. At the end of the 2017/2018 program year 92.4% of enrolled preschool children and 87.7% of infants and toddlers met or exceeded the widely-held state expectations for kindergarten readiness.





















HOME REHABILITATION

The Comprehensive Housing Rehabilitation Program exists to help eligible homeowners repair their homes to achieve decent, safe and sanitary affordable housing as defined by Macomb County Housing Rehabilitation Standards. The program limit for repairs is \$40,000.

WEATHERIZATION

The Weatherization Assistance Program performs the installation of energy efficient items to conserve energy in Macomb County homes. Weatherization improvements reduce energy use and can save an average of 30 percent on heat and utility bills. A home energy audit determines which items will be installed.

Energy Saving Services may include:

- Wall insulation
- Attic insulation and ventilation
- Floor/foundation insulation
- Air leakage reduction
- Furnace repair or replacement
- Other energy saving measures



HOME INJURY PREVENTION PROGRAM (HIPP)

The Home Injury Prevention Program installs devices to ensure safety and prevent falls and injuries in the home. Installation of various safety devices are the key to this unique program and includes bathtub grab bars, bathtub chairs, handheld showerheads, raised toilet seats/rails and interior/exterior handrails.

ACCESSIBILITY PROGRAM

The Macomb Community Action Accessibility Program is a one-time, grant-funded program designed to make site-built residential homes in Macomb County more accessible to residents in need. Accessibility modifications are limited in scope to those items that will create easier access within the home for elderly and disabled occupants. Accessibility modification costs cannot exceed \$5,000.00 from all funding sources.

Types of modifications may include items such as; ramps, grab bars, handrails, trip hazard removal, minor bathroom modifications, etc.

The Accessibility program currently serves eligible residents in 21 of the 27 Macomb County communities.






CHORE SERVICES

Chore services provide seasonal assistance with grass cutting and snow removal. The program is available to persons age 60 and older who are residents of Macomb County that meet eligibility guidelines.

MINOR HOME REPAIR

The Macomb Community Action Minor Home Repair Program allows one (1) repair call/visit per year per eligible household. The visit may address multiple repairs but total cost may not exceed \$500. Repair items are limited in scope to the repair or replacement of a damaged or malfunctioning component part of a building feature or system.

The Minor Home Repair Program currently serves eligible residents in 13 of the 27 Macomb County communities.



Macomb Community Action - Office of Senior Services offers a multitude of programs and services that support the ever-growing senior population of Macomb County. Senior Services staff members work diligently to ensure seniors are safe, well-nourished and empowered to remain active and independent.

MEALS ON WHEELS

Meals on Wheels is designed to reach older adults who are homebound and unable to prepare meals for themselves. Our volunteers deliver a locally prepared, hot nutritious meal, directly to the seniors' door. This service also acts as an opportunity to provide human contact and reducing instances of isolation, depression, and anxiety.

Annually, Macomb County participates in the national March for Meals campaign. Every March, Meals on Wheels programs across the country come together to celebrate this proven collaboration of local community organizations, businesses, all levels of government and compassionate individuals.




RESOURCE ADVOCACY

ADULT DAY CARING CENTER

Through a unique partnership with Martha T. Berry Medical Care Facility, Macomb Community Action provides a health and social service model of care for individuals with physical and cognitive disabilities. Caregivers are comforted as they leave their loved ones in a home-setting while receiving opportunities for socialization, supervision and medical care. This cost-effective alternative rivals other forms of health care, such as home health and/or home nursing care and offers the following:



- Home environment
- 1:4 Staff to Participant Ratio
- Flexible Attendance options
- Cognitive and sensory stimulation activities
- Daily exercise
- Participant community outings
- Nutritious meals and snacks
- Incontinence care
- Personal care such as bathing available

On September 13, 2018, an official ribbon cutting ceremony took place to commemorate the new look and name of Macomb County's Adult Day Center, now called the *GoldenBerry Adult Day Caring Center*. To help improve the home-style environment that the center promotes, a renovation project took place between July and November 2017. These renovations provided changes such as shower area improvements, new bedroom furnishings, new appliances and much more.

Funding for the renovations was made possible by the Area Agency on Aging 1-B and the Macomb County government.
