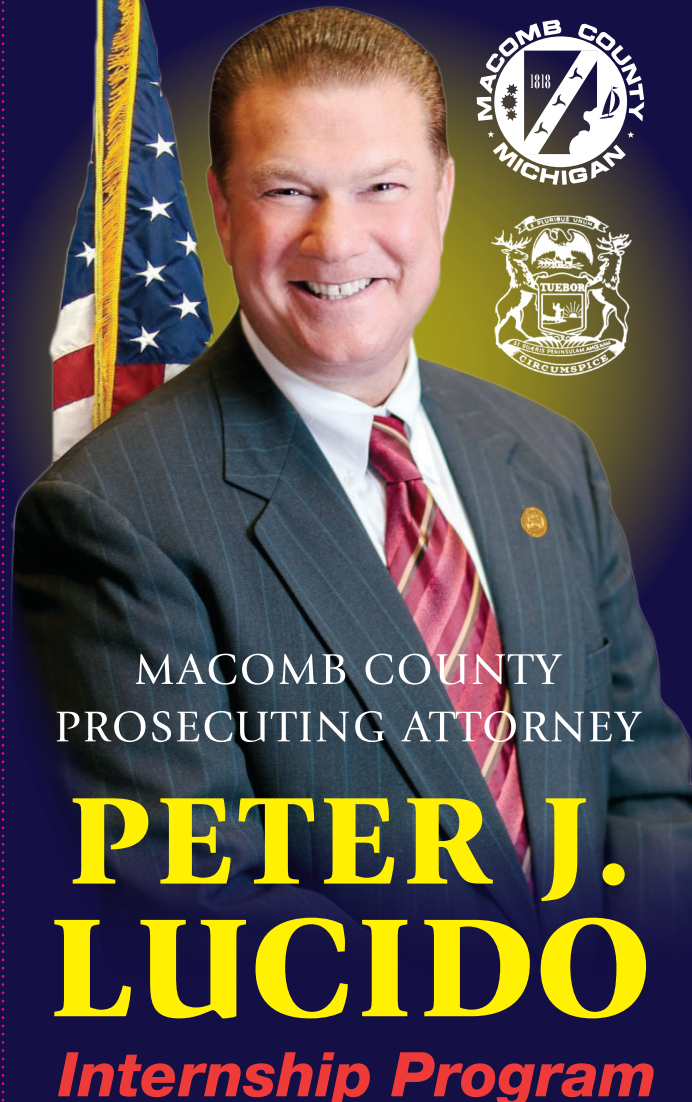

# INTERNSHIPS FOR UNDERGRADUATE STUDENTS

Undergraduate and graduate interns provide administrative assistance to Macomb County Prosecutor Peter J. Lucido and staff in areas ranging from communications to general office administration while having the opportunity to learn and experience the prosecutorial process.

Some responsibilities will include: filing, drafting correspondence, data entry, and special projects as assigned.

**Minimum Qualifications:** Applicants should be enrolled in an undergraduate or graduate level academic program, possess strong written and verbal communication skills, have an interest in learning about the inner workings of a Prosecutor's office, and enjoy the idea of assisting others through public service.



# INTERNSHIPS FOR LAW SCHOOL STUDENTS

The Macomb County Prosecutor's Office internship program for law school students provides the unique opportunity to gain "hands-on" experience while being directly supervised by a Macomb County Assistant Prosecuting Attorney. Pursuant to Michigan Court Rule 8.120, law school student interns are given the authority to appear and represent the People of the State of Michigan in court proceedings under the supervision of an assistant prosecutor. Law school interns typically engage in activities such as plea negotiations, bench trials, formal hearings, case review, legal research, and appellate brief writing. Some may appear at various court proceedings. Student interns may also have the opportunity to prepare and conduct one or more jury trials. This program is geared toward students interested in courtroom and appellate experience.



# MORE INFORMATION ON INTERNSHIPS

Internships last approximately 10-12 weeks depending upon each student intern's academic calendar. These positions are unpaid, at-will, and each intern serves at the pleasure of Macomb County Prosecutor Peter J. Lucido. The intern is responsible for the coordination of any academic, scholarship, or grant benefit as a result of participation in the program. Upon entering the program the intern will be required to and must agree to participate in any and all security measures similar to those required by a new assistant prosecuting attorney. The intern shall also cooperate with any requirements imposed by the Macomb County Human Resource Department. Furthermore, upon acceptance into the Macomb Prosecutor Internship Program, the student intern understands the requirement to learn and abide by all office policies and conduct themselves consistently with the Michigan Professional Code of Conduct.
