

The meeting was opened to public participation. Ms. Miller explained the purpose of the drain and the maintenance that is being done. A SAW Grant was received for the Sterling Relief Drain which allowed for inspection of the entire drain to determine needed repairs.

Approximately ten Sterling Heights residents attended the meeting. Last cutting season, the drain was mowed to the top shelf of the drain. Residents are concerned about fires, vermin and insects becoming more of a problem if the entire drain is not mowed. They are against the drain being developed as a bike path.

Mr. Bednar updated the Board on the SAW Grant project. A project update meeting will be held on April 23, 2018 to discuss asset inventory, condition assessment and findings of the televising of the underdrain. District delineation will be performed by Ms. Hissong, Fahey, Schultz, Burzych, Rhodes, PLC to determine if the Sterling Relief Extension Drain and its tributaries are all part of the Sterling Relief Drain. A grant was applied for through the EPA. This money will be used to stabilize the drain to slow the flow in major wet weather events.
