


Hetchler Relief Drain

1. Pipes

a. Pipe Segment 163M003-163M004:
 There are 3 temporary plastic plug bulkheads that need to be replaced with permanent bulkheads.
 These plastic plugs are located at approximately 468 feet, 504 feet, and 625.5 feet upstream of Manhole 163M003.









b. Pipe Segment 163M019-163M018: Hole located at the 12 o'clock position, approximately 44 feet downstream of Manhole 163M019 that requires re-grouting.



c. Pipe Segment 163F001-163M005:
Plastic plug bulkhead that needs to be replaced with a permanent bulkhead. This plastic plug is located approximately 417 feet downstream of Manhole 163M005.





d. Pipe Segment 163F001-163M005:
 12-inch catch basin tap with a 6-inch corrugated plastic pipe protruding into the mainline located approximately 320 feet downstream of Manhole 163M005.



e. Pipe Segment 163M022-163M004: Two infiltration gushers located at joints approximately 323 feet and 328 feet downstream of Manhole 163M022. Manhole ring found approximately 690.5 feet downstream of Manhole 163M022










f. Pipe Segment 163M001-163Z001: Two surface reinforcements visible (SRV) at break-in taps located approximately 315 feet and 566 feet downstream of Manhole 163M001.





g. Outfall 1637001: Heavy rock and debris removal at Outfall Structure 163Z001.





i. Pipe Segment 163M006-163M023:SRV at break-in tap located approximately 234 feet upstream of Manhole 163M023.









k. Pipe Segment 163M028-163M026: Metal cage located approximately 132 feet upstream of Manhole 163M028.

Manhole frame contains cracks along the lip. Heavy mineral deposits located at the 6 o'clock position in the pipe.


