

The homeowners association asked that we wait until after summer to complete the work and we agreed. Next month we will be investigating the best use of available SAW funds. The bulkhead and dewatering of the pipe is a huge expense and what was laid out for Lake Boulevard was to only do the main branch. Fishbeck ran the numbers to do extra feet and it will not cover all the additional branches. The main cost is putting in the bulkhead and given that it has not been inspected since the 1960's and 1970's, we will likely be recommending that we go ahead and inspect all of the branches while in there already.
