

Tetra Tech is in the process of creating a historical map to truly understand which drains we would like to consolidate to best use the money from SAW to maximize the number of feet of pipe that we inspect. Once the rainbow map is complete and we know which assets are with the drain currently, which assets we might add, we will have a recommendation on which pipes to inspect. In about a month the rainbow map will be finalized and there will be a recommendation on how to proceed.
