

The meeting was called to order by the Chair, Candice Miller. The agenda was approved as presented.

The meeting was opened to public participation, then closed, there being no comments from the public.

Mr. Gapshes updated the Board on the Marsack Gravel Pit property. In 1987, the Rohrbeck Extension Drain purchased property from the Marsack family to be used for detention in wet weather events. There was a 20-year agreement between the drainage board and the Marsack family to allow them to mine the property. There are concerns about what the gravel pits were filled with and the 378 feet of detention that was agreed upon has been reduced to approximately 285 feet. Some of the slopes have to be rebuilt to the original specifications. Ownership of 8 parcels of land will be verified. Three quotes will be received from environmental firms to assess the property. There is a sign lease on the property that will expire this year. The existing company will be afforded an opportunity to renew the lease for an increased amount.

The Chair presented the invoice totaling \$3,771.50 to the board for review and approval.
