

The meeting was called to order by the Acting Chair, Brian Baker. The agenda was approved as presented.

Minutes of the meeting of June 12, 2017 were presented and approved on a motion by Mr. Romano, supported by Mr. Baker and unanimously carried.

The meeting was opened to public participation. Jared Beaudoin, City of Sterling Heights expressed concern that the City of Sterling Heights ordinance that requires grass be mowed at 6 inches or less is not being adhered too. Mr. Forlini responded that while that may have been the case in the spring due to heavy rains, the mowing is in compliance with the City's ordinance. The ordinance states that grass must be mowed at least 24 feet from developed land and 160 feet from the road. Residents have begun mowing the bottom portion of the drain. No trespassing signs should be posted along the drain. A meeting will be held to discuss these issues.

The public participation portion of the meeting was closed.

There was no work on the SAW Grant in June 2017. The open channel will be inspected in July 2017. The CCTV contractor will perform the inspection on the 48-inch underdrain.

The Chair presented the invoices totaling \$1,332.50 to the board for review and approval.

Motion was made by Mr. Romano, supported by Mr. Baker to approve the invoices as presented.

A motion to receive and file the financial report given by Mr. Manning was made by Mr. Romano, supported by Mr. Baker and unanimously carried.

The meeting was adjourned at 10:45 a.m. on a motion by Mr. Romano, seconded by Mr. Baker, and unanimously approved.
