



Subject: Drain Maintenance Contract Authorization - LJ Construction

MCPWO have identified a significant maintenance project required on the Rohrbeck Extension Drain in the City of Roseville. The maintenance work includes bank stabilization, channel re-alignment and miscellaneous repair of discharge connections. The locations include the area south of 13 Mile Road between the Gratiot I-94 Connector and west bound I-94, the area east of Little Mack and west of I-94 and the area west of Little Mack off Erin Street. A map of each location and pictures are attached for reference. MDOT will be funding separate repairs to their drainage.

MCPWO obtained a proposal from LJ Construction to perform the maintenance required to stabilize the drain in each of the areas identified. LJ recently successfully completed similar work on another drain project. Their pricing has the lowest of all bidders and we seek to utilize them for this project while they are in the area. The cost summary for each location is as follows:

- Erin Street \$13,695.00
- Famous Dave's \$59,550.00
- Red Roof Inn \$60,495.00

The Total proposed maintenance cost is \$133,740.00. The MCPWO recommends an approximate 20% contingency of \$30,000 for unforeseen circumstances that may arise during construction.

The Rohrbeck Extension currently has \$14,890 available in the drain account. MCPWO identified that the Roseville Storm Drain Improvement Program No. 3 & Roseville Catch Basin Repair Program No. 4 Drain accounts as a funding source for this and future maintenance projects. The respective Drain Boards will authorize the transfer of approximately \$15,857 from the Roseville Storm Drain Improvement Program No. 3 and \$204,347 from the Roseville Catch Basin Repair Program No. 4 drain accounts. The approximate total amount transferred to the Rohrbeck Extension Drain is \$220,204 which brings the total drain account balance to approximately \$235,094.

The recommendation is that the Rohrbeck Extension Drain Drainage District Board authorize entering a maintenance contract with \Box Construction for the Not-to-Exceed amount of \$163,740.00 and to make payment to \Box Construction upon completion of the work.
