

#### **MCPWO Closes on Property Sales**

The Macomb County Public Works Office has closed on the sale of two properties, netting nearly half a million dollars to local drain funds. A third property, a commercial parcel on M-59, is scheduled for an auction sale later this year.

In the first sale, the office sold a house on Eberlein Drive in Fraser near the location of the 2016-2017 sewer collapse along 15 Mile Road. The MCPWO had purchased the home as a precautionary measure while repairing the sinkhole that developed as part of the sewer collapse. It was later determined the home was still structurally sound and the house was listed with a local realtor. The sale netted \$233,968 to the Macomb Interceptor Drain Drainage District. The home was purchased by a family for use as their residence.

Public Works Commissioner Candice S. Miller said the idea of the family moving in to the house on Eberlein represents "a return to normalcy" in the neighborhood most directly impacted by the sinkhole repair.

The second property is approximately a 4.5-acre parcel along the Hawken Drain, just west of Ryan Road, between 19 Mile and M-59 in Sterling Heights. The sale of that property netted \$249,712 to the Hawken Drainage District. A private developer purchased the property and indicated a plan to develop several single-family homes in the area.

"These sales not only return these properties to the local tax rolls in Fraser and Sterling Heights, but they generate revenues that we can use to make improvements to these drains. This office is not in the business of holding on to excess property forever. Our purpose is to ensure the proper operation of the drains to enhance local quality of life and serve as a critical component of economic activity," Miller said.

Revenues in the MIDD fund will be used to support ongoing maintenance and upkeep of the system, which provides sanitary sewer service to more than a half million residents and businesses in 11 Macomb County communities. Two other lots in the area of the 15 Mile sewer collapse are in the process of being placed for sale. Both of those lots, one on Eberlein and one on 15 Mile, are vacant.

The Hawken Drain funds will be used to repair or maintain drains in Sterling Heights.

The Public Works Office will be using a public auction in the fall to sell a nearly 9-acre parcel at the northeast corner of M-59 and Garfield Road. That parcel, owned by the MIDD, has an appraised value of several million dollars.

"These properties have been held by this office in some cases for decades, which makes no sense to me. We want to utilize our resources in a way that brings direct benefits to our ratepayers by re-investing in our underground infrastructure needs," Miller said.

The sales of the Fraser and Sterling Heights properties were approved by the Drainage District Boards in each of the respective districts.
