


## **Enclosed Gravity** - < 60" Dia

Commissioner, 21777 Dunham, Clinton Township, Michigan, on July 10, 2017, at 10:19 A.M.

The meeting was called to order by the Acting Chair, Brian Baker. A motion was made by Mr. Smith, supported by Mr. Baker and unanimously carried to approve the agenda as presented.

Minutes of the meeting of May 8, 2017 were presented and approved, with the caveat that Mr. Smith was not present, on a motion by Mr. Baker, supported by Mr. Smith and unanimously carried.

The meeting was opened to public participation, then closed, there being no comments from the public.

Fishbeck, Thompson, Carr & Huber (FTCH) has begun calculating the probability of failure. The calculations then determine the consequence of failure which is reported as part of the asset management. There have been issues with the County's GIS matching up with the Public Works data. Three of the four bulk-heads have been constructed and will be installed to allow for inspections and to locate illicit discharges. Doetsch is the contractor performing the work.

A motion to receive and file the progress report update given by Mr. Graboske was made by Mr. Smith, supported by Mr. Baker and unanimously approved.

The Chair presented the invoice totaling \$8,811.50 to the board for review and approval.

Motion was made by Mr. Baker supported by Mr. Smith to approve the invoice as presented.

Motion approved.

A trial balance sheet was presented to the Board by Mr. Manning. The SAW Grant is ongoing. The remaining balance on the SAW Grant is \$513,687.00.

A motion to receive and file the financial report given by Mr. Manning was made by Mr. Smith, supported by Mr. Baker and unanimously carried.

The meeting was adjourned at 10:24 a.m. on a motion by Mr. Smith, seconded by Mr. Baker, and unanimously approved.

Report Period – July 3, 2017 to August 6, 2017

The following is a summary of work completed to date, and the anticipated work for the next month:

### Work accomplished during the report period:

### 1. Geographic Information System (GIS) System Development

- a. FTCH substituted data from the existing Macomb County drain database for the 11 1/2 Mile Relief Drain to address the syncing issues associated with the software.
- b. FTCH staff updated ownership information for the sewers and drains in the GIS database.
- c. FTCH staff coordinated with Macomb County Planning staff for the transfer of data to the Macomb County GIS system.

### 2. Field Inspections

- a. Doetsch Environmental has completed construction of the bulkheads and installed them onsite for the 11 1/2 Mile Relief Drain.
- b. FTCH staff has prepared a summary of manholes and catch basins remaining to survey using the Global Positioning System (GPS), and manholes to inspect for the 11 1/2 Mile Relief Drain. 217 of approximately 659 storm manholes and catch basins have been surveyed, and 198 of approximately 294 manholes have been inspected.
- c. FTCH is currently preparing a summary of manholes and catch basins remaining to survey using GPS, and manholes to inspect for the Stephens Relief Drain.

### 3. Data Analysis

a. FTCH has begun calculating the probability of failure (POF) scores for the sections of pipes inspected for both drains.

### Anticipated work items for the upcoming report period:

### 1. Field Inspections

- a. Doetsch Environmental will bulkhead, dewater, and inspect the remaining sections of the 11 1/2 Mile Relief Drain.
- b. Once the 11 1/2 Mile Relief Drain inspection is completed, Doetsch Environmental will bulkhead and dewater the Stephens Relief Drain and begin inspection.
- b. FTCH will survey the remaining manholes and catch basins in both drains.
- c. FTCH will inspect the remaining manholes in both drains.

### 2. Data Analysis

- a. FTCH to begin determining the consequence of failure (COF) for the pipes and manholes for both drains.
- b. FTCH will continue calculating the POF scores for the sections of pipes inspected for both drains.
- c. FTCH to continue updating the GIS database with the information found during sewer televising and manhole inspection.
- d. FTCH to begin analyzing the results of the sewer inspections as Doetsch Environmental completes the work.
