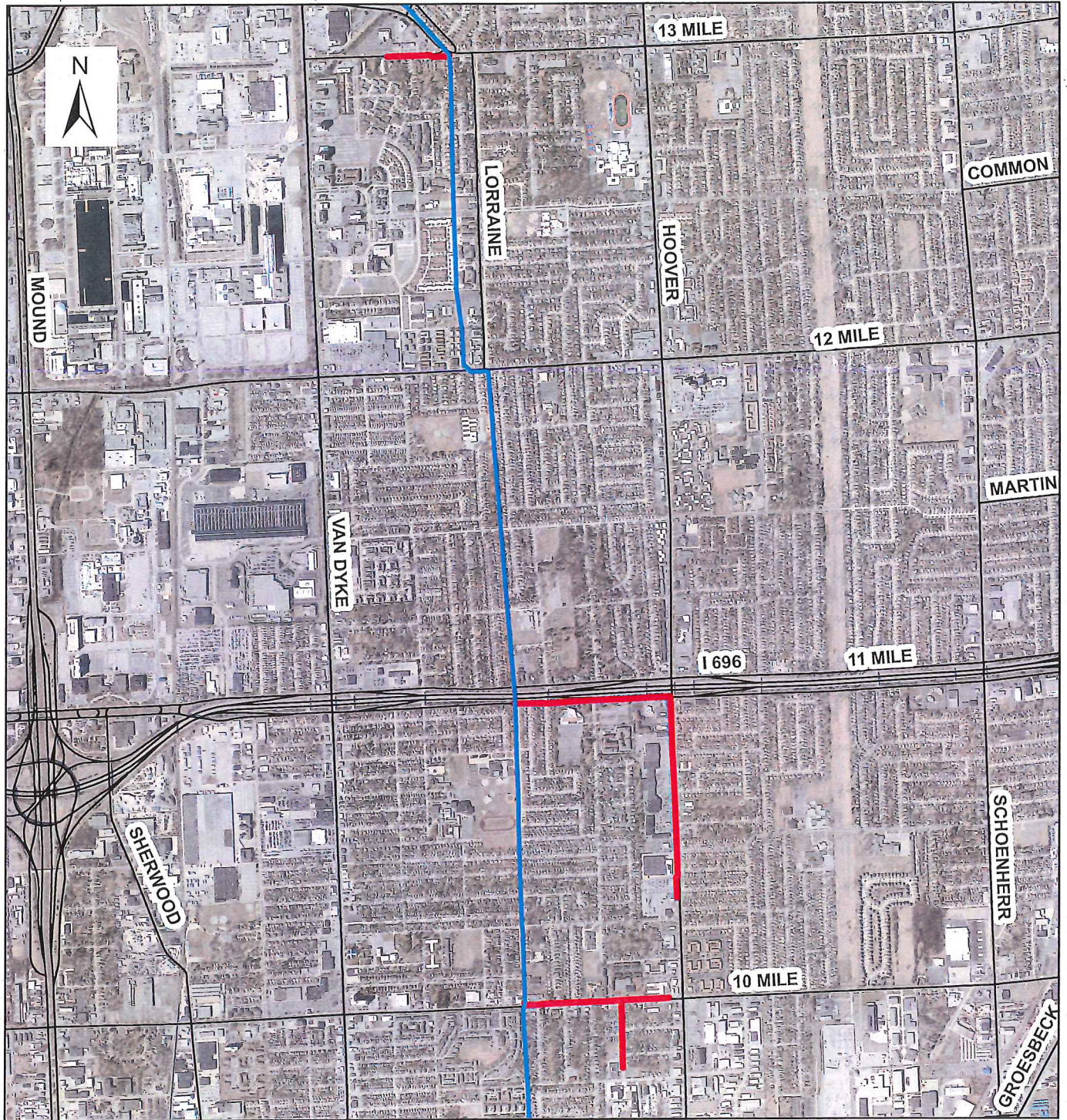

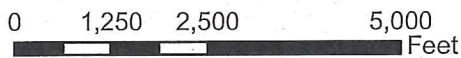

The chairman read into the record the following motion:





Subject: Lorraine Storm Drain Emergency Repair

The Macomb County Public Works Office (MCPWO) engineering staff were made aware of a potential collapsed portion of the Lorraine Storm Drain in the City of Warren. A site investigation revealed that a section of 12" CMP in the rear yard of 28867 Los Olas, south of 12 Mile Road, has collapsed. The section of compromised 12" CMP is located beneath the resident's swimming pool, which is located within the drain easement and without a license to use agreement.

The repair will consist of grouting and abandoning the existing 12" CMP that is beneath the pool and removal of the existing 24" catch basin. A new 24" catch basin will be installed and new 12" RCP will extend to the existing 11' pipe. This will mitigate future conflict with the pool and provide a new reliable connection to the drain. The work will require traffic control along 12 Mile Road and fence removal/replacement of fencing at four addresses. A map of the location has been attached for reference, notes are included to illustrate the repairs. The duration of the work is estimated at three days for a total cost of \$37,640. The proposal for the repairs is attached for reference.

The Lorraine Storm Drain currently has \$5,300 of funds available. The MCPWO provided a recommendation to the City of Warren to transfer existing drain account funds from three other drain accounts within the City to cover the repair costs. The fund transfer summary is shown in the table below:

Jim,

We have been in contact with Warren staff on a drain complaint located in the rear yard of 28867 Los Olas. A compromised 12" CMP is located beneath the resident's swimming pool which is unfortunately located within the drain easement without a license to use agreement. The compromised portion of pipe has caused concrete settlement damage around the pool. We would like to expedite repairs.

The repair will consist of grouting and abandoning the existing 12" CMP that is below the pool and removing the existing 24" catch basin. A new 24" catch basin will be installed and a new 12" RCP will extend to the existing 11" pipe. This will eliminate any future conflict with the pool and provide a new reliable connection. This work will require traffic control along 12 Mile Road and removal and replacement of fence at 4 addresses. A map of the location is attached for reference, notes are included to illustrate the repairs.

The addresses for the four homes directly affected are noted below. A letter will be drafted to the homeowners and we will also talk with them directly prior to starting the work.

The duration of this work is estimated at three days due to the proximity to the homes and 12 Mile Road. The total cost to complete the repairs is \$37,640. The Clancy Contracting proposal is attached for reference. This project would be difficult to quote/bid out due to the emergency nature and unique circumstances, so we recommend Clancy do the work - they are our lowest priced contractor to do this type of repair. The Drain District is not paying for any cost the homeowner incurs to repair the concrete that has settled or cracked.

We recommend proceeding with this work immediately, after which we can transfer the funds into the needed Chapter 20 drain district.

We just need your request for us to transfer the funds which we will then take to the 9/14 Chapter 20 Drain Board meetings. Candice will give Marv Sauger a heads up. We suggest transferring funds from the Lorraine #1, Lorraine #2, and Sprenger drains to the Lorraine Storm to complete the repairs.
