

Mr. Bednar updated the board on the drain inspection project. Areas of joint separation have been found which may be allowing soil into the drain. There are areas near the northern part of the drain where the pipe either has not been installed straight or it has shifted over time. The drain currently holds water where the pipe sags. If the water has always been there, it shouldn't be a problem but if this is something new, it could possibly lead to larger problems. The drain is not in a green-belt so work on this drain would be expensive. This matter is being investigated. It also has been discovered, and is being investigated, that the southern end of the Merrill Drain where it discharges into the Plumbrook Drain is lower than the Plumbrook Drain.

Subject: Hildebrandt Pump Station Fence Upgrade

The Macomb County Public Works Office (MCPWO) is facilitating the design and rehabilitation of the Hildebrandt Drain Drainage District Pump Station along Hayes Road near 17 Mile Road in Sterling Heights. The project consists of a new precast concrete wetwell, two pumps, electrical, SCADA, trees and fencing along Hayes Road. The current total project cost is \$840,000, which includes replacement of the existing chain link fence with new black vinyl coated chain link fence. The City of Sterling Heights requested that our office obtain a quote to upgrade the black vinyl coated chain link fence to a decorative ornamental wrought iron fence, which is a similar initiative at other locations in the City along road ways.

Upon review of the fence upgrade quote and assessment of available drain account funds in the City of Sterling Heights, the City Manager has requested a transfer funds from the Merrill Drain Drainage District account into the Hildebrandt Drain Drainage District account to upgrade the fencing enclosure along Hayes Road from black vinyl coated to a decorative ornamental wrought iron fence. The total transfer amount is \$17,000. The Merrill Drain Drainage District account has a balance of \$56,000 and was inspected two years ago with no major maintenance issues identified. The remaining balance in the Drain account will be \$39,000 which is sufficient to manage future maintenance or repairs.

The recommendation for the Merrill Drain Drainage District Board is that this Board approve the transfer of \$17,000 to the Hildebrandt Drain Drainage District account to facilitate the requested fence upgrade.
