

Subject: Schoenherr Relief SAW Grant Project

The prime contractor for the Schoenherr Relief and Branches SAW project has requested a \$15,000 increase in fees due to unforeseen increases in the complexity of the project. I believe the price increase is justified since the work performed vastly exceeded the original project scope.

The original scope of the Schoenherr Relief SAW Grant Project included only the Main Schoenherr Relief Drain, which is approximately 5.5 miles long and only included inspection of 50 manholes. We asked Tetra Tech to revise the scope dramatically:

Additionally, the revised scope included a new line item for Fahey Schultz Burzych Rhodes to perform drain delineation research. This was prior to the start of data collection, or before the county had digitized the drains for the project. Additionally, Tetra Tech needed to secure a permit from the Macomb County Department of Roads and their inspection fees were also paid out of Tetra Tech's existing contract.

The approximate 3% price adjustment requested is very minor given the substantially better asset management product being prepared for the District.

Dear Mr. Bednar and Ms. Miller,

The following text documents the history of the Schoenherr Relief Drain SAW Grant Project.

The original scope developed in conjunction with Macomb County for the Schoenherr Relief SAW Grant Project was submitted in November of 2013. The scope included the Main Schoenherr Relief Drain, which is approximately 5.5 miles long. Since there was no mapping at the time, Tetra Tech was to GPS locate and inspect approximately 50 manholes and draw the drain in the County's GIS system. We would then clean and televise the drain, perform an engineering assessment of the drain and prepare an Asset Management Plan for the County.

The State awarded the contract in December of 2017. By this time, the staff had changed significantly at the County. The project scope was reviewed with the current staff to confirm if the scope was still relevant. After some discussions, it was decided that since the drain had been inspected in 2006 and there were a significant number of associated drains that had never been reviewed, available funds would be better to inspect the associated drains. We were asked to prepare a new project scope with three options. Option 1 was the Original Drain; Option 2 was all the drains that emptied into the main Schoenherr Relief Drain and option 3 was all the drains that were in the area. (See attached map). After several meetings, the County elected to proceed with Option 1 and Option 2 as the new project scope. This allowed for several additional subdrains to be inspected utilizing the original \$490,000 Grant amount. At the same time the County was working with Fahey Schultz Burzych Rhodes to determine which drains were actually owned by the County and what the service area was for the Schoenherr Drain. Tetra Tech was asked if we could include \$15,000 in our budget for Fahey Schultz Burzych Rhodes to perform the research. At that time, late 2018, Tetra Tech indicated we would be able include this. It was however before we had started any data collection, or before the county had digitized the drains for the project.

We are now in the closing months of the project and have been trying our best to leave the \$15,000 in our scope of work for the Fahey research. After reviewing our budget this month, we believe that we do not have any remaining funds to complete the project and include this \$15,000 within our current budget.

Just as a comparison, the original scope was to CCTV and Clean 5.5 miles of Drain and GPS 50 manholes. As of this month we have collected the following information:

Manholes 445

Tap Lines 680 (many not shown on previous maps)

Catch Basins 295

Enclosed Gravity Segments 271 19.75 Miles

Inlets/Outlets 43

MH 3D Scans 320

CCTV 13.5 Miles (15" to 114")

GPS Locations 752 (438 Manholes, 314 Catch Basins)

We are currently updating the County GIS system to reflect this new information. All this data is to be condition assessed and analyzed for inclusion into the Asset Management Plan.

In addition to the large amount of data collected and analyzed, we did initially work with Stacy Hissong from Fahey to review historical drain data and attempted to prepare the rainbow maps she requested. Scope of this effort confirmed that this was a process that Tetra tech was not familiar with and we advised the County to contract with a firm more familiar with the process.

Another unanticipated cost item was for the need to secure a permit from the Macomb County Road Commission for the cost of a permit and their inspection fees to work within the County Road right-of ways. This fee was an additional \$1,600 which Tetra Tech paid out of our existing Contract.

The COVID-19 Pandemic also had some effect on the project to the extent that we needed to ramp up the CCTV during this time in order to complete the project on schedule.

We are prepared to complete our work efforts within our original contract amount without being able to support the budgeted fees of Fahey, Schultz, Burzych, Rhodes as anticipated.
