

- 1. Set up traffic control on Beaconsfield.
- 2. Protect the curb and sidewalk with crane mats in order to cross sidewalk with equipment.
- 3. Supply and place a road plate over the sidewalk.
- 4. Supply and place all necessary safety fence to secure the entire work site.
- 5. Sandbag pipe in manhole west of the proposed excavation in order to stop the water flow.
- 6. Set up a pump and discharge hose to the next manhole located in Beaconsfield roadway.
- 7. Mobilize all necessary equipment including a large excavator, small excavator, skid steer, air compressor, portable light plant and generator to run the bypass pump.
- 8. Locate and protect all underground utilities.
- 9. Excavate between utilities and load out, haul off and dispose of all spoils.
- Supply and place all necessary trench boxes to support the banks during excavation.
- 11. After reaching the assumed pipe separation we will excavate around and under the 48 inch concrete pipe in order to do the repair.
- 12. We will then supply four U shaped anchor rods, drill holes into each pipe in order to connect the
- 13. Supply and place a re-rod cage around the entire pipe joint, cage will be about 10 inches wide.
- 14. Supply and place a concrete band around the cage, this band will be a minimum of one foot wide and one foot thick.
- 15. After the concrete cures we will then supply, place and compact all necessary sand backfill to fill the excavation.
- 16. All sand bags will be removed from the upstream manhole.
- 17. We will then supply, place and spread all necessary top soil on the entire disturbed area.
- 18. We will then seed and straw the area.
- 19. All equipment will then be demobilized from the site.
- 20. In the event the sidewalk next to Beaconsfield is damaged we will then replace same.
- 21. We will inspect and repair any restoration that is needed until grass has germinated.
