

The Chairman called the meeting to order at 10:16 a.m.

A motion was made by Mr. Suma, supported by Mr. Nash to approve the agenda as presented.

The minutes of the meeting of December 19, 2017 were presented. A motion was made by Mr. Suma, supported by Ms. Miller to approve the minutes as presented.

The project is on-hold during the winter months. A resident called in to say that there was trampling of the vegetation in the NOAA staging area. Mr. Mickalich will assess the damage today and determine what remediation if any should be done. Mr. Mickalich said that there are funds remaining in the EPA portion of the grant. This money could be used to plant trees along the staging area to protect it. Installing a fence would not be covered under the grant and would require maintenance. A list is being made for the maintenance responsibilities such as operation of the weir to vegetation maintenance practices. Discussions will be held with Clinton and Harrison Townships, the Huron-Clinton Metropolitan Authority (HCMA), HRC and the Macomb County Public Works Office to discuss maintenance. The results derived from these discussions will be presented by the March meeting. A meeting is being held with regard to

insurance on the fishing pier next week. Mr. Wiley asked if there were any signs posted at the staging area site. He suggested that an ordinance be written governing the use of the Spillway. Temporary signs will be installed after discussions with the insurance company. By installing signs, this would allow the local governments to issue citations.

A motion was made by Mr. Suma, supported by Mr. Nash to authorize the Macomb County Public Works Office to install signs along the Spillway.

Mr. Bednar spoke about HRC's engineering costs for contract administration. HRC has requested that money be transferred from the Gloede and McBride Drain projects to the Clinton River Spillway project. Mr. Bednar contacted the EPA for their approval since these monies cover all three projects.

A motion was made by Mr. Suma, supported by Mr. Wiley to receive and file the project update given by Mr. Bednar and Mr. Mickalich.

Mr. Bunch, Six Rivers Land Conservancy gave a presentation on what his organization does. The Six Rivers Land Conservancy is a private, non-profit agency that serves as a regional land conservancy for the northern portion of the Detroit Metropolitan Area. The sole purpose is to acquire land and interest in land for conservation purposes to preserve some of the natural, agricultural and scenic heritage of the region. Mr. Bunch went on to explain some of the projects that the Conservancy has been involved in. Just in the North Branch Clinton River and Belle River Watersheds, 166,000 acres have been identified for preservation.

The Conservancy would be interested in acquiring the Spillway property. The property would be maintained as passive recreation. They do not have the resources to maintain the property or take resident complaints.

Mr. Nash spoke about the residents wanting the parcel to remain undeveloped. If the land were controlled by the Six Rivers Land Conservancy, he felt certain that the residents would assist in maintaining the land for passive recreation. Mr. Bednar spoke about Clinton Township taking the parcel on as a park. The township has the manpower to maintain the property. There are a number of options with regard to the six acres of land on Sheffield. The Drainage Board will have to determine what direction it would like to go with this land.

The Chairman presented the invoice totaling \$517.15 as provided to the Board for review and approval.

Motion was made by Ms. Miller, supported by Mr. Wiley to approve the invoice as presented.

On May 17th, 2017, personnel from the U.S. Army Corps of Engineers Detroit District, Oakland County Water Resource Commission, and the Macomb County Drainage Commission completed the annual inspection of the Clinton River flood control project. A list of inspection attendees and findings is included below.

Project Description: The authorized project provided for construction of a cut-off canal extending from a point on Clinton River approximately 1,500 feet downstream of the Gratiot Avenue Bridge to Lake St. Clair, approximately 12,500 feet (2.4 miles).

Authorization: The Federal project for local flood protection at Mount Clemens, Clinton River, Michigan was authorized by the Flood Control Act approved July 24, 1946 in accordance with House Document 694, 79th Congress, 2nd Session.

Project Sponsor: Clinton River Spillway Drainage Board

Summary of Findings: Below is a summary of significant findings noted during our inspection. Select photographs are included in this report, with a complete set included in the enclosed CD, along with a Google earth kmz file. Photograph numbering on captions references the photograph file name for easy location.

- 1) The Clinton Spillway Weir has not been operated for several years. Current management at Macomb County have been actively maintaining the weir to ensure it is operational, and plans to resume operation. During our inspection, Macomb County had a contractor on site removing large trees and woody debris that had collected at the weir (Photo 60). No significant issues with the weir were noted in the field (Photo 61).
- 2) The Corps of Engineers and Macomb County recently constructed habitat features along the Clinton River spillway, near Harper Avenue. These features are not part of the flood control project, but are adjacent to the spillway (Photo 66 & 67). The features are outside of the channel, and are not expected to impact flood conveyance,
- 3) At the time of our inspection, bank restoration near the outlet to Lake St. Clair had been recently completed. The erosion control fabric on the south side was poorly anchored, and appeared to be loosely placed on top of the riprap. Grass cover was not coming in well at the time of the inspection (Photos 71 & 72). Re-seeding and erosion control may be needed if sod cover does not establish well.

Summary: Overall, the Red Run Drain project is in "Minimally Acceptable" condition, and the project will remain active in the 84-99 program.

Enclosed with this report are electronic copies of all photos, and a Google Earth .kmz file showing the location that each photo was taken in Google Earth format. Please reference previous annual inspections conducted by USACE for additional information regarding past project conditions, recommendations, and improvements or alterations that have been made.






Photo 60: Large trees in channel near the Clinton River Spillway Weir. The trees were being removed via a winch during the inspection.




Photo 61: Clinton River Spillway Weir. No major structural defects noted.




Photo 62: Clinton River Spillway Weir, with Clinton River in the background. Note woody debris.




Photo 71: Bank restoration near Lake St. Clair (south side). Erosion fabric appears poorly anchored.




Photo 72: Bank restoration near Lake St. Clair (north side). Sod cover needed.
