

The Chairman called the meeting to order at 10:11 a.m.

The minutes of the meeting of February 26, 2019 were presented. A motion was made by Ms. Vaara, supported by Ms. Miller to approve the minutes as presented.

The meeting was open to the public participation, Dana Duggar, resident of Clinton Township, presented photos and updates on the state of the Spillway to the board. Photos shown: only half the planting of the evergreens by Harper has survived; dirt bike damage on the Spillway; the need to re-seed East of Harper; a shell of a boat was dumped at the end of Union Lake; fence in the staging area that is damaged due to the unloading of trees; access point by the bridge could use a post to make it less accessible to motor vehicles; parking area with damage from a 4x4 vehicle; illegal dumping near north end (Harper) of the parking area; more dumping on south side of Union Lake by the bike path; storm water drain erosion that appears to be coming from the nursing home; north side still has dumping left from last year. Dana contacted Clinton Township to see if some Eagle Scouts would be interested in refurbishing the rest area benches on the south side by the bike trail. Dana talked to State Representatives regarding funding to purchase the 6 acre parcel, the bill has cleared the House and he hopes that some of the funds could go towards maintenance of the Spillway such as mowing.

Mr. Baker stated that we did go out and tag the boat and will have Tammy follow up. Mr. Gregg stated that the motorbike and 4x4 vehicle issues are enforcement issues and it is tough to block off pedestrian access.

Mr. Bednar updated the board that there is not a warranty on the trees, however the contract is still open and we will hold the contractor accountable to replace them. Mr. Burton then updated the board that they will be checking over the property now that trees and plants are blooming to see what is alive and dead before the closure of the contract. They expect to have an updated report next month with timing for replacement and clean up. Expected close out is October.

General Liability, Non-Owned Automobile Liability, and Public Officials' Liability – all afforded on an Occurrence basis excess of a retained limit.
