

The meeting was open to public participation. Mr. Duggar stated he toured the the southside of the Spillway area with the Clinton Township Clerk regarding the cleanup of debris. She was very interested in getting it cleaned up and has organized a cleanup for the weekend with the assistance of the Macomb County Public Works Staff. If anyone is interested in helping or has any questions they can contact the Clerk.

Mr. Bednar updated the board that the EPA grant is now in maintenance mode and we are scheduling the spring training event for late April or early May to complete treatment of the Spillway. We will be requesting an extension of the grant for the seeding that will take place in the fall.

We are bringing back an idea of a Master Plan for the Spillway which will be brought to the board later this year.

We were contacted by a non-profit organization called Green Michigan that does roadside cleanup and they would like to plant roughly 40 trees along the Spillway this spring. Mr. Bednar met with them and discussed the type of tree they would like to plant, including location and maintenance of the trees.

A motion was made by Mr. Wiley, supported by Mr. Suma to authorize Macomb County to collaborate with Green Michigan on the planting of approximately 40 trees.

On October 1<sup>st</sup>, 2020, representatives from the U.S. Army Corps of Engineers Detroit District and the Macomb County Public Works Office completed the annual inspection of the Clinton River flood risk reduction project. A partial list of inspection attendees is included below.

In 1952, the Corps of Engineers constructed a cut-off canal extending from a point on Clinton River about 1,500 feet below Gratiot Avenue Bridge to Lake St. Clair, a total distance of about 12,500 feet. The project also includes a control weir at the upstream end of the project to ensure low-water flow in the natural river channel. Riprap was placed at the weir, along the south bank of the river above the weir, and at Gratiot Avenue Bridge.

The following items were noted:

a. The weir was submerged, and only the concrete abutment walls were visible. What could be inspected was in fair shape, with some efflorescence noted. A detailed inspection of the weir and electrical equipment during lower flows is recommended.

- b. Riprap was not observed near the weir. The banks are heavily vegetated and may be covering the riprap. Clearing vegetation from the banks to allow for inspection, maintenance, and to prevent damage to the weir structure from tree roots or fallen trees is recommended. Riprap should be replenished if it has been displaced.
- c. Erosion was noted along the cutoff channel downstream of Jefferson Avenue. Stabilization using riprap or other methods suitable for the flow conditions is recommended.
- d. The area of stabilization on the left bank of the channel near the downstream end of the project has several sinkholes noted. It appears soil and erosion control fabric were placed on top of the existing stone, and soil is being lost through the voids in the stone. Separating the soil and rock with a properly installed filter fabric would resolve this issue.

Overall, the Clinton River Flood Risk Reduction Project is in "Minimally Acceptable" condition, and the projects will remain active in the 84-99 program.



## **SUBJECT**

Spillway pedestrian bridge engineering

## Background:

The current bridge over the Spillway at Jefferson has no accommodations for pedestrians and this creates a significant gap in our path system. Macomb County Planning and Economic Development has been helping us with this, and they have identified funding sources that could help with the cost to build this bridge, but in order to apply, we must have preliminary engineering completed. Late last year we learned of a potential grant that could help to fund the preliminary engineering for a pedestrian bridge over the Spillway at Jefferson. We applied and recently learned that our application was approved. We are very grateful for this grant from the Community Foundation of Southeast Michigan Ralph C. Wilson, Jr. Legacy Fund.

Wade Trim submitted an initial proposal of \$46,000.00 for this work. We initially applied for a \$40,000.00 grant, and proposed \$6000.00 in matching funds to come from our DDA Fund. The grant was approved for \$33,000.00. We went back to Wade Trim and asked them to look for ways to reduce the scope of the project and ultimately the cost.

Attached is their revised proposal for \$41,000.00 for this project. I am recommending that we accept the grant from the Community Foundation of Southeast Michigan Ralph C. Wilson, Jr. Legacy Fund in the amount of \$33,000.00, authorize Wade Trim to complete the preliminary engineering for a Pedestrian Bridge over the Spillway at Jefferson at a cost of \$41,000.00, and approve \$8000.00 in matching funds from the DDA fund for this project

Dear Mr. Verkest:

Harrison Township, in conjunction with Macomb County will be applying for a Ralph C. Wilson, Jr. Legacy Design and Access Grant. Grant proceeds are proposed to be used to prepare a preliminary design and scoping document for a pedestrian bridge across the Clinton River Spillway at Jefferson Avenue. You have requested that Wade Trim provide a proposal to complete the preliminary design. The project will include opportunities for public input and will result in a report with a preliminary design, conceptual cost estimate and renderings that can be used to apply for grants for the design and construction of the facility.

## Understanding of The Project

Harrison Township currently has over eight miles of non-motorized trails throughout the Township. One discontinuous location is the crossing of the Clinton River Spillway at Jefferson Avenue. The Township would like to make this connection to complete a vital part of their non-motorized trail along Jefferson between St. Clair Shores and the Lake St Clair Metropark. Harrison Township in conjunction with Macomb County Planning Division would like to develop a Schematic Design plan and report for this project location that results in an overall "master" plan. The Schematic Design is intended to be used by the Township and County to apply for various grants through MDOT and SEMCOG in 2022.

Throughout the process, Wade Trim will assist the Township in public engagement strategies to allow the public to provide input that may influence design options and the final preferred schematic design. Wade Trim will prepare public engagement materials and have a representative in attendance at no more than two public meetings related to this project. We assume that the Township will handle meeting logistics including meeting time. We assume during this time that meetings will be virtual to be in compliance with the current State of Michigan COVID-19 social distancing protocol.

## Scope of Services

## Task 1: Pre-design and Field Investigation

## 1.1 Scope Verification

Wade Trim will organize a kick-off and scope verification meeting with key Township and County staff to confirm schedule and scope of work to be performed. At the kick-off meeting, existing site information will be reviewed, and the collective group will discuss and prioritize project goals for the bridge. We anticipate two options to be discussed at the scope verification. Option 1 will be widening the existing Jefferson Avenue vehicular bridge to accommodate a pedestrian pathway, and Option 2 will be a separate freestanding pedestrian bridge, west of the Jefferson Avenue Bridge.

An initial field investigation will consist of the following:

• A field walkthrough of the bridge site, including a review of the condition of the adjacent Jefferson Avenue bridge to assess whether it could be used as a temporary platform for construction cranes during construction of the proposed pedestrian bridge. If there is load rating information available, we will request that from Macomb County. A field investigation of the Jefferson bridge will also be done to determine the applicability of widening the Jefferson bridge to accommodate a pedestrian pathway.

Locating any existing utilities that may be in the vicinity of the project which may cause conflicts with any proposed construction.

 A review of the site to assist in determining site features for the proposed bridge and to gather information on site aesthetics and amenities.

## 1.2 Topographic Work

Wade Trim will request existing topographic survey information from recent adjacent projects to the proposed bridge site. It is assumed at this time that this topographic information will suffice for the schematic design. Possible supplemental survey information can be picked up by Wade Trim survey crews. We are assuming this will be limited to one day of field work and half a day of processing. We will also refer to current GIS and USGS mapping of the area. The bridge mapping area includes mapping to the edge of water and river soundings if none exist.

- If existing elevations of the riverbed (i.e. soundings) do not exist, Wade Trim can provide a remote bathymetric survey drone to obtain sonar soundings within the limits of the proposed pedestrian bridge.
- The survey effort presently excludes a boundary survey and title review. These services are available upon request as an additional service.

## 1.3 Geotechnical

Wade Trim will rely on existing geotechnical information provided by the County and the Township. It has been suggested that recent construction activities north and west of the proposed bridge site will have relevant geotechnical information that can be used to possibly ascertain the subsurface soils for foundation recommendations. Wade Trim would also reach out to the Macomb County Department of Roads for existing plans on the Jefferson Avenue bridge to reference the geotechnical information from those plans. At this time a geotechnical investigation is not anticipated.

## Task 2: Design Alternatives

Wade Trim will evaluate findings from Task 1 and develop design options for the pedestrian bridge and adjacent related amenities. Options will be informed by the project parameters and goals as determined by the project team in conjunction with Township and County staff for each component. Wade Trim will develop the two options for each scope area described below.

## 2.1 Bridge Alternatives

The design team will confirm the preferred bridge design characteristics with the stakeholders that will guide potential bridge options. These characteristics will include items such as:

- Single span versus multiple span
- Bridge width: Clear width for pedestrian/bicyclists and accommodations for fishing at appropriate locations
- Shared use or separate pedestrian/bicycle lanes
- Vehicular load requirements (AASHTO required H-vehicle or client specific)
- Bridge materials (Steel, concrete, timber, etc.)
- Special aesthetic features, including viewability from bridge (open railings and/or overlooks)
- ADA compliance

We understand that the bridge options will need to respond to the existing environmental conditions that will minimize natural feature impacts and be resilient to floodplain and floodway issues. Wade Trim will work to develop potential solutions.

We will look at a maximum of three bridge alternatives for each option from an aesthetic perspective, site constraints, constructability, cost constraints, long-term maintenance, and public perception. We will meet with the stakeholders to discuss the project, their vision for the project, funding, constraints, and other pertinent issues. Based on the findings from these stakeholder meetings, we will further the alternatives to incorporate into a Feasibility or Structure Study. We will prepare a report with presentation drawings that highlight positives and negatives of the different alternatives, including price and constructability. The report will be generated and submitted to the stakeholders for review and consideration. We anticipate a follow up meeting to be held between Wade Trim and the stakeholders. From these meetings, the desired outcome is a consensus on the type of pedestrian bridge to move forward with in the future design stage.

## 2.2 Site Amenities

Wade Trim will evaluate the interface of the existing pedestrian pathway with the proposed pedestrian bridge and the adjacent shoreline of the Clinton River Spillway and develop alternatives to improve site amenities for pedestrians, bicyclists and fishermen who would like to utilize the water's edge for sport or relaxation. Accessibility and functionality from the pathway and bridge will be evaluated and alternative plans will be developed independent of the bridge alternatives.

2.3 Design Alternatives Public Engagement

The Wade Trim design team will meet with the Township and County to review the design options developed for the bridge and site amenities and incorporate requested revisions prior to developing final public meeting presentation graphics. Wade Trim will prepare two graphic schematics for each option to present at a public meeting. Alternative public engagement may also be incorporated including online surveys.

## Task 3: Schematic Design Master Plan

The design team will meet with the stakeholders following the public engagement of the design options and confirm a consensus schematic master plan approach to the bridge replacement and potential site amenities. Following this meeting, Wade Trim will prepare final schematic documents including a rendered colored schematic plan of the bridge. A preliminary opinion of probable construction costs will also be developed. This will aid the Township and County in preparing grant application submittals for the proposed improvements. The final schematic plan deliverable will also include a summary of anticipated regulatory permits required to construct the work, construction logistic parameters for replacing the bridge and potential construction phasing options.

## **Schedule and Compensation**

The grant requires that all grant funded activities be completed in a 12-month period. A schedule is included with the grant application that shows starting work in May of 2021 and completing the scope of services by April of 2022. We are ready to begin work upon notification that the Township has received the grant and receipt of a notice to proceed. We propose to complete the scope of services as outlined in this proposal for a Lump Sum amount of \$41,000.

Dear Clinton River Spillway Board Members,

As you may know, I am a member of the Detroit Zoological Society Board of Directors. In April, the Detroit Zoological Society (DZS) announced an initiative in collaboration with ReLeaf Michigan to plant a total of 2,000 trees in 2021-2022 across communities in Metro Detroit.

My team here at MCPW met with the DZS and Harrison Township officials and have agreed to partner with the DZS with planting 100-150 large caliper trees at the Clinton River Spillway at both the Jefferson park as well as within the naturalized area just west of Jefferson. By adding these trees it will help capture sediment, nutrients and waste from stormwater runoff before they enter the spillway and ultimately Lake St. Clair. These trees will filter windblown sediment and airborne pollutants caused by erosion, and increase wildlife habitat. By providing beauty and shade from these trees, it will enhance the quality of the human habitat as well, as more and more residents enjoy this recently restored natural area.

While our GLRI funded project design included many trees to be planted within the Spillway on both sides of Jefferson, the actual size and extent of tree plantings needed to be reduced due to budget constraints. Of the trees that were planted, some have not survived, particularly trees of smaller caliper size. To increase survivability, MCPW staff and the DZS have discussed selecting hardier species at 1.5"-2" caliper size. Those species include hackberry, serviceberry, honey locust, Dutch elm resistant elm, bald cypress, dawn redwood, ginkgo, tulip and as well as various species of maple, oak, and evergreen trees. Other survival strategies will include soil amendments and water bags which will be serviced by Harrison Township.

The DZS has asked the Clinton River Spillway Board to match their pledge of \$15,000 for this project to proceed. Harrison Township has agreed to provide the long term maintenance of the planted trees.

I am requesting the Clinton River Spillway Board authorize the amount of \$15,000 to match the pledge from the DZS towards this initiative. I sincerely appreciate the DZS graciously agreeing to our request, as well as the enthusiastic cooperation received from Harrison Township.

## Clinton River Spillway parcel sold to Clinton Township

A portion of vacant land along the Clinton River Spillway has been sold to Clinton Township with the understanding the property will be used for recreational use only.

The parcel, approximately 6.3 acres, is located along the north side of the spillway, just east of Harper Avenue and north of Metropolitan Parkway. The sale of the acreage to the township for \$377,940 was approved by the Clinton River Spillway Drainage Board and the Clinton Township Board of Trustees.

To pay for the land, the township obtained a grant through the Michigan Natural Resources Trust Fund.

"The township is to be commended for applying for, and getting, the grant," said Macomb County Public Works Commissioner Candice Miller, who serves as secretary on the inter-county drain district board that manages the Spillway. "The public is well-served by this sale. It's an example of a good government partnership that keeps it under local control. The property will be preserved for public use."

As a condition of the grant awarded by the Michigan Department of Natural Resources, the township is required to use the parcel for recreational purposes only, such as a park.

"We're thrilled to be getting this property," Clinton Township Supervisor Bob Cannon said. "We're anxious to put our trust fund money to good use for recreational purposes."

Cannon said the township board will determine a specific land use after welcoming suggestions from nearby residents.

"We want to make sure it'll be something the Spillway drain board and nearby residents will be happy with," the township supervisor said.

Proceeds from the sale of the property will help pay for continued maintenance of the spillway such as the removal of logs and other debris in order to maintain the flow of the water in the channel and to operate the nearby weir.

"Clinton Township's eventual use of the 6.3-acre parcel will further enhance the aesthetics and attraction of the Spillway," Miller said.
