

The Chairman called the meeting to order at 10:20 a.m.

A motion was made by Mr. Nash, supported by Mr. Baker to approve the agenda with an updated quote for item #6.

The minutes of the meeting of November 20, 2019 were presented. A motion was made by Mr. Nash, supported by Mr. Baker to approve the minutes as presented.

The meeting was open to public participation, then closed, there being no comments from the public.

Mr. Bednar updated the Board that we anticipate hearing back from General Motors during the first quarter of next year regarding improvements to the Bear Creek. The project manager, Lou Urban from AEW is coming in soon to give us an update on where the project stands.

A motion was made by Mr. Baker, supported by Mr. Nash to receive and file the project update by Mr. Bednar.

Mr. Stockel updated the Board that there is a buried manhole along the Bear Creek Branch west of TACOM. It was a staging area for MDOT and there is about 7 feet of cover on the structure. We plan to raise it and re-grade. We will request MDOT reimburse us for this cost.

A motion was made by Mr. Baker, supported by Mr. Wiley to approve the quote from Robert Clancy Contracting, Inc. in the amount of \$5,450 to raise the buried manhole on the branch of the Bear Creek.

Mr. Stockel updated the Board on old business regarding the BP gas station. BP has excavated the contaminated soil and are currently backfilling and compacting. They did find an old CMP tap and crock pipes for old drainage that oil came spilling out when they excavated. They grouted the pipes and will re-tap the drain.

Mr. Bednar also updated the Board regarding past conversations on the consolidation of the drain accounts. A recommendation has come to us regarding an engineering contractor that we should use to complete the project. A proposal will be put together to present to the board.

Mr. Bednar updated the Board on new business regarding the I-696 green ooze. They have begun cleanup of the chemicals found on site and have established another pumping station on I-696 along with a trench on the service drive. They found it could impact our drains due to the chemicals flowing from the North/Northeast and getting in the pipe itself from the trench and entering our Sharkey Drain. Testing has shown no issue for the residents in the area. They will soon test the service drive storm sewer to determine if there is chemical in there and where it could travel. Bear Creek samples have come back less than the drinking water standard.

A motion was made by Mr. Baker, supported by Mr. Nash to authorize Macomb County Public Works to engage ECT for testing services at a not to exceed cost of \$5,000.
