

#### 1.) BEAR CREEK INFRASTRUCTURE REHIBILITATION

- a. AEW provided preliminary estimate for rehabilitation and replacement repairs. (\$785,330.00)
- b. AEW, MCPWO and OCWRC conducted a meeting to discuss prioritization of rehabilitation locations.
- c. Based on this meeting a revised estimate was provided (\$601,260).
- d. AEW to postpone infrastructure rehabilitation until the condition assessment, review and recommendation are complete for the Bear Creek Branches.

#### 2.) BEAR CREEK EXTENSION

- a. Oakland County WRC to field verify physical existence of the Bear Creek Extension and report findings at the January meeting.
  - Depending on the results of the field investigation, potential coordination with Fahey,
     Schultz, Burzych, Rhodes may be needed to execute petition.
