

A meeting of the Inter-County Drainage Board for the CLINTON RIVER SPILLWAY DRAIN was held in the Office of the Macomb County Public Works Commissioner, 21777 Dunham Road, Clinton Township, Michigan on September 27, 2017.

(HRC)

The Chairman called the meeting to order at 11:40 a.m.

A motion was made by Ms. Miller, supported by Ms. Vaara and unanimously carried to approve the agenda as presented.

The minutes of the meeting of August 23, 2017 were presented. A motion was made by Ms. Miller, supported by Ms. Vaara and unanimously carried to approve the minutes as presented.

Mr. Mickalich, HRC updated the Board on the NOAA and EPA grant projects. Photographs of the project were shown to board members. The contractor has been making a more concerted effort to irrigate new vegetation. Cassie Lovell, NOAA and Mr. Mickalich walked the site. The outstanding construction budget for the NOAA portion of the grant is \$322,000. There is a \$68,000 difference between the grant amount and the budget amount, of which \$30,000 will be used for post-monitoring as required by NOAA. The remaining balance of \$38,000 can be used for additional improvements. HRC is currently working with Anglin to produce a balancing change order which will be available for the next meeting. This may generate additional excess funds which can also be used for additional improvements. The grant end date is December 31, 2017. After conversations with NOAA and the EPA, a no-cost extension will be granted until December 31, 2018. A fish shocking will be performed in the fall and again in the spring. NOAA requires notation of what types of improvements have been made to fish habitat. Some of the monies will be used for insurance on the fishing pier, weir and the out-building and liability insurance. Ms. Lovell asked that a wish-list be prepared for future work to be done on the Spillway. HRC will continue to monitor future funding availability. There is a NOAA internal award granted between federal agencies and the Spillway project is a good candidate to be recognized at the award ceremony. That would put a spotlight on this project and be helpful for future funding. HRC is submitting an award application to the Michigan Association of County

Drain Commissioners on behalf of the Inter-County Drain Board. Another video was done of the Spillway project and is currently being edited.

Cardno is currently preparing to do spot treatments on the phragmites along the Spillway. Mr. Mickalich reiterated to the board that treatment of the invasive species will be a continual maintenance project in the coming years. Two-inch in diameter trees will be planted along the bank at Jefferson. Ms. Vaara commended HRC, contractors and the board for all the hard work put into this project. Mr. Mickalich stated that native species were planted on this project to reduce the amount of maintenance along the Spillway. The Cooperative Invasive Species Management Area (CISMA), a group consisting of the Macomb County Department of Planning & Economic Development and Department of Roads, Harrison and Clinton Townships, meet to discuss invasive species issues. Mr. Korth suggested HRC manage the invasive species inspections each year for the Spillway. Mr. Gregg suggested putting together a comprehensive maintenance plan that would incorporate the Spillway, functionality of the weir structure, who's assigned to perform the maintenance, phragmite control, insurance, litter control and the fishing pier so that a budget can be developed to reflect these costs moving forward. Mr. Burton will put together a spreadsheet that can be built on to develop the maintenance plan.

A motion to receive and file Hubbell, Roth & Clark's report was made by Ms. Vaara, supported by Ms. Miller and unanimously carried.

Spalding DeDecker Associates is conducting surveys on two parcels of land along the Spillway and will have a report for the next meeting. Clinton Township's Master Plan will allow for a subdivision to be built on the larger parcel.

The Chairman presented the invoices totaling \$8,710.50 as provided to the board for review and approval.

Motion was made by Ms. Miller, supported by Ms. Vaara to approve the invoices as presented.

Motion approved.

A motion to receive and file the financial report prepared by Mr. Manning was made by Ms. Miller, supported by Ms. Vaara and unanimously approved.

The next meeting was scheduled for October 25, 2017.

There being no further business coming before the Board, the meeting was adjourned at 12:15 p.m. by Mr. Gregg on a motion by Ms. Vaara, supported by Ms. Miller.
