

The Chairman called the meeting to order at 10:12 a.m.

A motion was made by Ms. Miller, supported by Mr. Nash to approve the agenda as presented.

Mr. Dugger, Clinton Township resident expressed concern over the Board's decision to move forward with the sale of the property on Sheffield. The drainage district has owned the property since 1952. Most residents are opposed to the property being developed. Residents would like the property to be retained and maintained as a serene open space. The property is currently used by local residents for recreational purposes. The Macomb County Department of Roads will not allow an access road to the property from Harper. This would mean that one of the three streets in the neighborhood would become a through street. Mr. Dugger also had issue with the fact that the property was not mowed until mid-summer. Clinton Township has an ordinance that requires maintenance of properties. Mr. Dugger asked the board to be an example of good stewardship. A vagrant camp has been set up along the south side of the Spillway, between Gratiot and Harper. Mr. Dugger asked that grading of the parking lot be included in the maintenance of the Spillway. He stated that if the property were to become privately owned, it would eliminate the residents' access to the Spillway.

Mr. Gregg said that the Board has not made a final commitment to sell the property. Steps have been taken to determine if the property is necessary for the performance of the board's duties and responsibilities. The revenue that could be derived from the sale of the property would create less tax burden on the balance of the drainage district. The Board saw an opportunity to benefit the entire drainage district. Mr. Gregg thanked the public for their positive comments and thought maybe there could be a creative way to achieve both of their objectives.

Mr. Wiley stated that St. Clair County has a very small portion of property in the drainage district. His constituents who live at the top end of the drainage district will be paying for the grass to be cut and will never use the Spillway. He believes in conservation, but the nest egg that the sale of the property would generate would reduce the tax burden on his constituents. If the property is developed, stormwater run-off would be addressed. There are volunteer groups that could maintain the property as long as liability issues were addressed. He asked that the residents put together a plan for maintenance of the property.

Mr. Lediet, Clinton Township resident stated the reason for buying his home was because it was a quiet neighborhood. He is concerned that a new development would bring an increase in traffic, street lights, sidewalks and stop streets. He feels it should remain the way it has been for years.

Mr. Brown, Clinton Township resident lives directly across the street from the Sheffield property. He stated that in the winter the area is pristine. If homes are built, fertilizer run-off will cause the river to become contaminated again, and the process of cleaning up the river will start all over again.

Ms. McMahen stated that all the wildlife and seclusion creates a country-like living environment. She cannot imagine having a subdivision across the street. If an association were formed by the residents, would they then be able to pay for the maintenance on the property.

A resident expressed concern over their property values if the land were developed. Ms. Miller thought the homes would be higher-end and would increase the value of the surrounding properties. Mr. Nash asked if there was a nature conservancy in Macomb County that would be interested in purchasing the property. Ms. Miller said that it is the responsibility of the Board to represent all entities in the watershed and determine what is best for the majority. In conversations with Clinton Township, Ms. Keskeny said that approximately 12 to 13 homes could potentially be built on the property.

Mr. Suma stated that five years ago when this project began, he felt that the communities benefitting from the improvements to the Spillway should pay for the maintenance.

Mr. Gregg said that there is no pressure by the Board to sell the property, but to minimize costs to the entire drainage district if possible. The residents were asked to bring a proposal to the Board in March 2018.

A motion was made by Ms. Miller, supported by Mr. Wiley to take no further action on the sale of the property until the March 28, 2018 meeting.

Mr. Mickalich, HRC updated the Board on the NOAA and EPA grant projects. A no-cost extension until December 2018 was filed with NOAA. The fish shocking was done as part of the post-monitoring portion of the grant. The fish count was significantly lower for the bait fish, but the game fish count was higher. The off-line pools have become a hatchery for bait fish. It will take a couple of years for the work to come to fruition. Mr. Mickalich will work with Jeff Bednar and Ken Verkest and look at the vegetation in the Harrison Township park before making a decision to reopen. The project site is being monitored for erosion.

A motion was made by Mr. Wiley, supported by Mr. Nash to receive and file the Hubbell, Roth & Clark's report given by Mr. Mickalich.
