## **Program Year 2021 Annual Action Plan Substantial Amendment**

Macomb County is amending its 2021 Annual Action Plan to reallocate HOME and CDBG funding as follows:

**HOME Program Administration** – Funding for costs related to administration of the HOME program.

**HOME CHDO Operating**- Funding used to support the operating costs of eligible Community Housing Development Organizations (CHDO).

**HOME Tenant Based Rental Assistance (TBRA)** – Funding to provide rental assistance to income eligible families.

**HOME Housing Rehabilitation** - Funding to provide assistance to income eligible homeowners to complete necessary repairs to their home.

<u>HOME CHDO Set-Aside</u> – The Macomb HOME Consortium must set aside 15% of its HOME allocation for housing development activities in which Community Housing Development Organizations (CHDOs) are the owner, developer or sponsor. The project will provide funds for either rental or homebuyer projects (new construction or acquisition and rehabilitation of existing). The housing must benefit income eligible households.
