HEAD START

Head Start is an early childhood development and education program for income-eligible families. The program provides a range of services for pregnant women and families with children ages 0 - 5. We partner with each family to promote high-quality school readiness at no cost.

THE COMMUNITY SERVICES DIVISION

The Community Services division offers a wide variety of programs to residents and municipalities ranging from transportation services, housing services such as, weatherization and rehabilitation, and community development programs. Funding for the various programs includes but is not limited to the US Department of Housing and Urban Development (HUD), the US Department of Energy (DOE) and the US and Michigan Departments of Transportation (DOT and MDOT).

ACTION CENTERS (586) 469-6999

Our Action Centers offer services to income-eligible Macomb County residents to diminish poverty and promote independence through rent/mortgage and utility assistance, and other programs.

TRANSPORTATION (586) 469-5225

This department provides transportation to essential medical appointments and other specific locations for eligible Macomb County residents.

HOUSING REHABILITATION (586) 466-6256

The Housing Rehabilitation Program provides assistance to eligible homeowners to repair their homes to achieve decent, safe and sanitary housing. Assistance is provided in the form of a no-interest loan.

WEATHERIZATION ASSISTANCE (586) 469-6329

The Weatherization Assistance Program performs the installation of energy efficient items to conserve energy in Macomb County homes. These improvements reduce energy use and can save an average of 30 percent on heat and utility bills. A home energy audit determines which items will be installed.

MINOR HOME REPAIR (586) 466-6256

The Minor Home Repair Program is a grant-funded program that provides assistance to eligible homeowners to address minor home repairs.

ACTION CENTERS

Covid Emergency Rental Assistance (CERA) - Keep Macomb Your Home

CERA helped thousands of Macomb County residents who faced COVID-related hardships with rent assistance, utility assistance and other assistance to avoid eviction and provide financial relief. MCA worked in coordination with Michigan State Housing Development Authority to implement multiple rounds of funding provided by the U.S. Department of the Treasury.

HOMEOWNER/RENTER ASSISTANCE

Community Services Black Grant (CSBG) Coronavirus Aid, Relief, and Economic Security Act (CARES)

CSBG CARES provided assistance with rent, mortgage, utilities and burial expenses for eligible households who were seeking assistance due to the COVID pandemic.

Bureau of Community Action and Economic Opportunity (BCAEO)MEAP (Michigan Energy Assistance Program)

Assists eligible households with electric and gas utilities, such as DTE, Consumers Energy and SEMCO to prevent utility service disconnection.

Water Residential Assistance Program (WRAP)

Provided households with water bill assistance and minor plumbing repairs and conservation to reduce water usage.

Supportive Services for Veteran Families (SSVF)

Provides eligible veteran households who are homeless or at risk of homelessness with services to obtain or maintain housing stability.

United Way for Southeastern Michigan Basic Needs and Winter Relief

UWSEM Winter Relief funding provided funds to assist with emergency housing during the winter months.

Bureau of Community Action and Economic Opportunity Low Income Household Water Assistance Program (BCAEO LIHWAP)

Low Income Household Water Assistance Program is limited funding available through September 2023 to assist eligible households with water and wastewater bills. The program started in FY 22 and provides Macomb County residents in participating communities with financial assistance toward their water/sewer bill arrears.

Show Me the Money Day

The Fourth Annual SMTMD was held virtually again this year. SMTMD had 106 participants register with over 11 different workshops to choose from. MCA collaborated with five community partners to cover timely topics, including:

- Bitcoin
- Accessing Social Security benefits
- Job training
- Growing your own vegetable garden
- Budgeting tips

Tax Preparation

Our partnership with Macomb County Veterans Services was another success.

A total of 2,002 returns were completed.

ACTION CENTERS

WRAP increased the number of assisted households in FY 22. MCA also took on the implementation of the WRAP plumbing repairs and conservation work. Great Lakes Water Authority, the funder and grant administrator, has continued to implement changes to WRAP to streamline the program for residents applying for assistance and the communities served by GLWA. Call 586-469-6464 for more information about WRAP.

In addition to WRAP, MCA received LIHWAP funding through BCAEO to provide help with water bill arrears for eligible households. When possible, Action Center staff are bundling these water assistance programs to maximize assistance to people who may have experienced difficulty maintaining water bill payments.

HOUSING AND HOMELESSNESS SERVICES UPDATES

In FY 22, Macomb Community Action expanded our work in the area of housing and homelessness services. Macomb Community Action now serves as the Housing Assessment and Resource Agency (HARA), a role designated by the Macomb County Continuum of Care and Michigan State Housing Development Authority. A HARA serves the community in multiple ways:

- Facilitates the prioritization and referral of households experiencing homelessness through the coordinated entry process
- Provides homelessness prevention and rapid re-housing assistance for people at risk of homelessness or who are currently experiencing homelessness
- Maintains Housing Choice Voucher Homeless Preference waiting list in coordination with MSHDA

Macomb Community Action was also selected by the Macomb County Continuum of Care (CoC) to serve in the role of the CoC Collaborative Applicant. The Collaborative Applicant agency completes and submits required Housing and Urban Development CoC components to obtain HUD funding for agencies serving people through housing and homeless services programs.

These vehicles can accommodate almost all individuals with disabilities. COMMUNITY DEVELOPMENT BLOCK GRANTS

COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) & CDBG CARES ACT (CDBG-CV):

The following projects utilizing CDBG and/or CDBG-CV funds were completed during the 2021-2022 program year. For a full list of projects completed during this time, please refer to the 2021 Consolidated Annual Performance Evaluation Report (CAPER) found at the QR code to the right.

Highlights:

- Provided 49 people with job training through Macomb Community College
- Made improvements to Roxana Park and aided in the reconstruction of Roxana Street in the City of Eastpointe
- Installed sidewalks in the Village of New Haven and Shelby Township



EMERGENCY SOLUTIONS GRANT (ESG):

During the 2021-2022, Macomb County's ESG and ESG-CV programs provided funding to MCREST, the Community Housing Network and Turning Point for rapid re-housing, shelter operations and homelessness prevention activities.

HOME INVESTMENT PARTNERSHIP PROGRAM (HOME):

During the 2021-2022 program year, Macomb Community Action completed the following projects utilizing HOME funds:

- In cooperation with the Community Housing Network, provided tenant based rental assistance to ten (10) households
- In cooperation with the Community Housing Network assisted two first-time homebuyers to acquire new homes

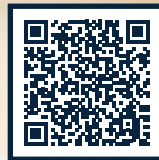

To provide greater community access, the Fresh Mobile is present at clinic locations once a month.

THE MACOMB COMMUNITY ACTION ADVISORY BOARD

The Macomb Community Action Advisory Board (MCAAB) is the advisory board for Macomb Community Action. MCAAB members are representatives from the public, consumer and private sectors.

One third of the Board members, appointed by the County Executive, are elected public officials currently holding office, or their representative(s). Appointed representatives shall have responsibilities which require them to deal with poverty-related issues.

One-third of the members represent the consumer sector. Representatives may be selected to represent the community or a specific area or neighborhood served by Macomb Community Action, or to represent a particular organization designated by the Advisory Board, whose membership is composed predominantly of economically disadvantaged persons, including youth organizations. One seat is reserved for a Head Start Policy Council member.

Finally, the last third, belong to the private sector as representatives of business, industry, labor, faith-based, law enforcement, education or other major groups and interests in the community served.

The Advisory Board members shall come from diverse backgrounds and life experiences in order to elicit a broad spectrum of knowledge, values and attitudes necessary for comprehensive consideration of issues affecting low-income individuals. Further, Advisory Board members will be selected in such a manner as to assure that they speak on behalf of the group or organization which they represent.
