

The meeting was opened to public participation, then closed, there being no comments from the public.

Mr. Bednar updated the board on the Red Run/Freedom Hill Project. The project was awarded to LJ Construction. They will be mobilizing starting today. Plans are to start on the Red Run side, doing all of the instream work in February and March. Then they will start working on the trail, grading and bringing aggregate in April/May. Plants should be planted in May/June. Then they will finish it off with concrete/asphalt work in June, then Fall plantings in September/October. MCPWO will be doing the inspection. Current construction schedule is that it will be wrapped up by Fall. We will be drafting up and sending out letters to notify the residents there.

Mr. Stockel updated the board with pictures from Ivy Street. We replaced the fence and a few months ago our inspector was out checking on the structures and noticed 2 sinkholes. One on each structure. The corrugated metal pipe is old, from the 1970's. We received 2 quotes. Robert Clancy Contracting was the low contractor. They repaired one for \$10,000 and the other for \$11,000. We replaced with concrete pipe and everything was put back together and restored.

It is located at the Western extent on Ivy Street, within 50 feet of the fence line.

Re: Request for Approval of U.S. Fish & Wildlife Service Grant Agreement

The attached agreement with the United States Fish & Wildlife Service (US FWS) specifies the cost share for a native prairie planting project on the western portion of the Sterling Relief Drain. The total project cost is estimated at \$14,140 with a landowner (Sterling Relief Drain) cost of \$2,890 in cash and in-kind match.

The project will convert approximately 17 acres of mowed turf grass in the western 0.8 miles of the Sterling Relief Drain right-of-way to native grass and pollinator habitat. This is the area of the drain that is fully enclosed and the land surface is currently maintained as mowed turf grass. This prairie conversion will continue the habitat improvements begun in recent restoration projects at the east stretch of the drain as well as the Red Run corridor along Freedom Hill. Along with improving stormwater infiltration, these projects provide habitat for migratory birds, butterflies and other pollinators as part of the Great Lakes Restoration Initiative (GLRI) program goals.

As part of the required cost share, MCPWO will perform site preparation by mowing and spraying the area. An additional establishment mow will be required at the end of the first growing season. The agreement mandates a 10 year maintenance period which could include annual maintenance mowing and spot invasive/weed growth control.

It is anticipated that the initial treatment will be contracted by MCPWO at an estimated cost of \$1,190. If necessary, an additional treatment will occur under the US FWS share of the project. The native seeds are provided by the US FWS, Partners for Fish and Wildlife Program.

This agreement will not preclude any future daylight or retrofit projects for the Sterling Relief Drain.

Staff requests authorization to execute the project agreement, including the required cost share. Upon authorization, the project will begin this spring.

PARTNERS FOR FISH AND WILDLIFE PROGRAM LANDOWNER AGREEMENT

This Landowner Agreement (Agreement) dated <u>January 23, 2023</u>, between <u>Macomb County Public</u> <u>Works Commission</u> (Landowner), and the U.S. Fish and Wildlife Service (USFWS) is entered into pursuant to authority contained in the Partners for Fish and Wildlife Act (P.L. 109-294), the Fish and Wildlife Coordination Act (16 U.S.C. 661 et seq.) and the Fish and Wildlife Act of 1956 (16 U.S.C. 742a-j), as amended. This project was selected for funding because the Landowner(s) share(s) a common objective with the USFWS to restore habitat for the benefit of Federal trust species on private lands, and the project supports priority actions identified in the Regional Partners for Fish and Wildlife (Partners) Program Strategic Plan.

Macomb County Public Works Commission, 21777 Dunham Rd, Clinton Twp, Michigan 48036, hereby agrees to participate with the USFWS in conducting certain wildlife management practices on lands owned or managed in <u>Sterling Heights Township</u>, <u>Macomb County</u>, in the State of <u>Michigan</u>, described as follows: all of, or within, <u>Township 2 North</u>, <u>Range 12 East</u>, <u>Section 29</u>, 30.

In signing this Agreement, the Landowner(s) join(s) as a participant in a wildlife habitat improvement program and grants to the USFWS authority to complete the habitat improvement project or the Landowner(s) may personally carry out management activities with financial or material support as described in attached Exhibits. Any donation of supplies or equipment to the Landowner for carrying out the habitat improvements is included in Exhibits. The activities conducted pursuant to this Agreement are not to replace, supplement or otherwise contribute to any mitigation or compensation that may be required of the Landowner(s) or other parties as a result of any mandated requirements.

The term of this Agreement (also referred to as the habitat retention period) will be completed on 1/23/2033. This Agreement may be modified at any time by mutual written consent of the parties. It may be terminated by either party upon 30 days advance written notice to the other party(ies). However, if the Landowner(s) terminate(s) the Agreement before its expiration, or if the Landowner(s) should materially default on these commitments, then the Landowner(s) agree(s) to reimburse the USFWS prior to final termination for the prorated costs of all habitat improvements placed on the land through this Agreement. For these purposes, the total cost of the habitat improvements to the United States is agreed to be \$2,550.00.

Landowner:

The Landowner(s) or his/her land manager, with legal authority over land management decisions, guarantee(s) ownership of the above-described land and warrants that there are no outstanding rights that interfere with this Landowner Agreement.

The Landowner(s) agree(s) to allow access (with advance notice) to the USFWS and the other cooperating partners to implement the project described in the work plan, and to monitor project success.

The Landowner(s) retain(s) all rights to control trespass and retains all responsibility for taxes, assessments, and damage claims.

At the end of the habitat retention period, the habitat improvement project will become the sole property

and complete responsibility of the Landowner(s). There shall be no obligation to the USFWS after the term of the Agreement has expired.

The Landowner(s) agree(s) to allow the USFWS to serve as his "agent" to secure the State of Michigan wetland permit, all other necessary permits the Landowner(s) are responsible to obtain. Technical advice and support will be provided by participating agencies in the application for the permit(s). The Landowner(s) agree(s) to identify USFWS' contribution to the project during public presentations, reports, or other information published about the project, as appropriate.

The Landowner(s) will be free to remove any structure at his/her own expense at the termination of the Agreement; however, the Agreement does not supersede any Local, State, or Federal regulation that would apply to the removal of any such structure(s).

The Landowner(s) will not be responsible for replacing wildlife habitat improvements that are damaged or destroyed by severe acts of nature.

USFWS:

The USFWS will work with the Landowner(s) and any other cooperators signing this Agreement, throughout the entire Agreement term to support actions needed to ensure that the project is designed and constructed per the Agreement and functions as intended.

The USFWS, its agents, or assignees will provide advanced notice prior to accessing the Landowner(s) property to implement the project described in the work plan, and to monitor project success.

The USFWS assumes no liability for damage or injury other than that caused by its own negligence, on the above acreage. The USFWS does not assume jurisdiction over the premises by this Agreement.

Spatial Information Sharing: In accordance with the Privacy Act of 1974, permis obtained from the Landowner before any personal information can be released. The that can be shared is payment information that is authorized by law. Description of Habitat Improvement Project and Objectives (see attached maps and drawings):

This project was funded through the U.S. Fish and Wildlife Service, Partners for Fish and Wildlife Program and the Great Lakes Restoration Initiative. The role of the Service is to provide financial assistance and to provide technical assistance to design and implement projects through the Partners for Fish and Wildlife Program. Specifically, the PFW Biologist provided cost share and technical assistance to design and oversee restoration of 17 acres of native grass and pollinator habitat in Macomb County, Michigan. The project will improve habitat for migratory birds, butterflies, and other pollinators. This project contributes toward achieving our goals in the Glacial Wetlands and Grasslands Focus Area and the Western Lake Erie Watershed.

Native Grass and Wildflower Establishment:

Macomb County Public Works Commission owns the Sterling Relief Drain Right-of-Way, which includes a partially enclosed, partially open drain system. They have begun efforts to create usable habitat in these areas by planting wet meadow mixes in the open, saturated areas. To increase the habitat value of the property, 17 acres of the enclosed (upland) areas will be converted from mowed lawn to native warm season grass and wildflowers to provide nesting habitat for migratory songbirds, monarch butterflies, and other pollinators. For site preparation, the landowner will have fields mowed and sprayed once with glyphosate in spring 2023. The U.S. Fish and Wildlife Service will pay for 1 glyphosate application prior to planting. The fields will be planted to 17 acres of a mixture of Big Bluestem, Indian grass, Little Bluestem and Side Oats Grama at 3.0 lbs. (PLS) per acre and wildflowers at 2.5 lbs./acre. The U.S. Fish

and Wildlife Service will order the native grass and wildflower seed and contract the planting of the field by June 2023. Pollinator Partnership is providing funding for the purchase of the native seed for this project. The landowner will be responsible for mowing the planted field once in 2023 after August 15th to control unwanted weeds and allow the native grass and forbs a better opportunity to become established on the project sites.

The USFWS will provide management advice to the Landowner during the life of the contract. Contact USFWS representative listed on the Landowner Agreement if you have any questions on the habitat restoration.

USFWS will:

- 1. Review, design and oversee completion of the project as described above and in attached documents.
- 2. Provide 17 acres of native grass and wildflower seed to the contractor for planting of the site in June 2023.
- 3. Reimburse the contractor (selected by Landowner and USFWS) for itemized project costs for spraying 17 acres.
- 4. Reimburse the contractor (selected by Landowner and USFWS) for itemized project costs for planting 17 acres of NWSG and wildflowers.
- 5. Upon completion of each portion of the project, conduct a final inspection with the landowner and contractors and review maintenance and management requirements with the Landowner. The USFWS can provide management advice to the Landowner(s) during the life of the contract.

The Landowner will:

- 1. Complete site prep by mowing and spraying the 17 acres of field once in spring 2023.
- 2. Mow 17 acres of field in August of 2023 per the recommendation from the USFWS after the planting of native grass and wildflowers.
- 3. Maintain grasslands for the length of the contract (10 years).
- 4. Assume all responsibility for all maintenance activities (mowing, brush control, and exotic/invasive species control) associated with the grassland project.
- 5. Contact the Service representative listed on the Habitat Development Agreement if you have any questions on habitat management. The Service can provide management advice to the landowner during the life of the contract.


