





An adjourned meeting of the Intra-County Drainage Board for the **MACOMB INTERCEPTOR DRAIN** was held in the Office of the Macomb County Public Works Commissioner, 21777 Dunham Clinton Township, Michigan on March 13, 2023, at 10:59 A.M.

The meeting was called to order by the Chair, Candice S. Miller. A motion was made by Mr. VanSyckel, supported by Mr. Santo to approve the agenda as presented.

Adopted: YEAS: 3 NAYS: 0

Minutes of the meeting of February 13, 2023 were presented. A motion was made by Mr. Santo, supported by Mr. VanSyckel to approve the minutes as presented.

Adopted: YEAS: 3 NAYS: 0

The meeting was opened to public participation, then closed, there being no comments from the public.

Mr. Downing presented photos of the Segment 5 Romeo Arm Interceptor. The contractors poured a concrete pad to work off of because of the wet conditions. The pumps will be going in this week. The photos also showed the spray lined sections of the pipe. There has been quite a bit of rain and there is about 4 weeks of spray lining left on the 8 foot pipe.

Mr. VanSyckel asked if the men that are spray lining are wearing just masks in the photo, or is there oxygen tanks attached. Mr. Downing said that they are just wearing masks but they do have escape packs on their person or nearby just in case. They also have ventilation and constantly monitor the atmosphere to keep fresh air in the work zone.

Mr. Downing said he is hopeful for the completion later this year and that it doesn't extend into next year. He said that we finally got our temporary construction permit reissued from ITC. We had been waiting since August.

Mr. Downing next presented photos of Segment 6. The CS13 gates are in place and we are working on getting them operational. They are working on getting the CS2 structure exposed for access to start the cleaning process between Control Structure 2 and 3.

Mr. Baker asked if they are going to put HOBAS through the CS2 structure. Mr. Downing said yes, the top comes off and the HOBAS goes in. He then showed a picture of the tail tunnel with the hydraulic jack mechanism. Mr. Baker asked if all of the HOBAS is in for Segment 6 and Mr. Downing said yes. They are working on the inside of the 15 Mile Interceptor and they will do the annulus grouting, then the HOBAS repairs will be performed with Ric-Man and the HOBAS representative. They have been working to get the foul air ducts layout configured. The open cut on Garfield will occur at night and will likely take 2 nights and we are hoping to complete that next month. We will coordinate with the Department of Roads.

Mr. VanSyckel asked if there will be any interference with Memorial Parades because of the timing and Mr. Downing said not that he is aware of. He said that right now we are tracking for a completion in the second week of June. As with Segment 5, Segment 6 has lost a couple weeks due to wet weather.

Mr. Astorino then updated on the Garfield Interceptor Lining Project. We are well over 300 feet complete so far. He then presented pictures and a short video showing the spiral liner machine feeding the lining. Mr. Astorino said the original plan was to have a small gap between the pipe and the new lining, but they stretched the machine out as far as they could to make it as tight as possible. We are hardly losing any pipe at all, plus with it going from concrete to PVC the flow capacity has increased due to the new surface. Ms. Miller asked how much the flow has increased and Mr. Astorino said he can get her the numbers.

Mr. Astorino updated on the Interceptor Inspection Program. We have a few minor punch list items to complete, but nothing significant in the major interceptors.

Mr. Downing said that there is nothing to report on Phase II grouting. The crew has not worked since July 2022 due to other competing project flow needs.

Mr. Downing updated on the Odor and Corrosion Control project. This project kicked off in January with work up at the NGI Pump Station to relocate a gas line. L. D'Agostini started with the foundation for the buildings as well as the tank pads.

Mr. Downing said that he met SAK and L. D'Agostini at the 21 Mile Road and Garfield site for a meet and greet as they will be working in coordination at the site. L. D'Agostini will be setting up the second week of April. Mr. Downing let them know that he would like to get traffic control out of there as soon as possible. They are coordinating with the same contractor to keep the closure consistent. There will be intermittent closures later on in the project but hopefully that will be resolved by the end of May which is the target for getting the road reopened.

We mailed a letter to the residents next to the NGI Pump Station off of Concordia letting them know that we would be in the area and if they have any questions to please get in touch with us.

A motion was made by Mr. Santo, supported by Mr. VanSyckel to receive and file the project updates.

Ms. Miller updated that the 2023 Report to the MIDD Communities has been distributed to all of the MIDD communities and elected officials for the MIDD communities.

Mr. Baker presented the proposed 2023/2024 MIDD budget totaling \$94.9 million. The sewer charges begin July 1, 2023. A little over half of the budget is from GLWA for treatment costs. GLWA approved a 2.3% increase to OMID which results in a 2.6% increase to the MIDD. GLWA is not passing on unpaid Highland Park charges. The total budget is up 2.9%.

A motion was made by Mr. VanSyckel, supported by Mr. Santo to approve the 2023/2024 Macomb Interceptor Drainage District (MIDD) budget and charges.

Adopted: YEAS: 3 NAYS: 0

Mr. Astorino updated on the Sewer Lining project. Right now at Garfield and 21 Mile Road, the Garfield Interceptor is being spiral wound. On the Southeast corner is the Macomb Township connection, and on the Northwest corner, we have one of the Shelby connections. Both of those pipes connecting the Garfield Interceptor have significant degradation. While we are already out there working in the area and have the traffic closures, we would like to line those degraded pipes with some cementitious lining. This will save costs, save time, and utilize existing traffic control. We received a proposal from SAK. Without having anything to compare it to, we sent out a full bid package to 7 pre-qualified lining contractors and only received one bid back from Municipal and Contractors Sealing Products Inc. for \$651,471. We decided to go with the proposal reformatted to match the bid form from SAK with a price of \$510,160.

A motion was made by Mr. Santo, supported by Mr. VanSyckel to approve the proposal from SAK Construction in the not to exceed amount of \$510,160 for the MA-S-2 & SY-S-3 Sewer Lining project.

Mr. Astorino updated on the Interceptor Inspection Program. We are utilizing laser profiling and sonar for inspection of the large interceptor. We need to see how much sediment is in there. During the last inspection from 2017, there was approximately 194,000 cubic feet of sediment. We are anticipating the number will be worse this time around.

A motion was made by Mr. VanSyckel, supported by Mr. Santo to award the Task 2 base bid amount of \$591,319.40 from the Taplin Group LLC to perform the work associated with the 2023 Interceptor Inspection Program.

The Chair presented the invoices totaling \$2,753,370.01 to the board for review and approval.

A motion was made by Mr. Santo, supported by Mr. VanSyckel to approve the invoices as presented.

Adopted: YEAS: 3 NAYS: 0 A motion to receive and file the financial report given by Mr. Manning was made by Mr. VanSyckel and supported by Mr. Santo.

Subject: Construction Projects Status Updates for April 2023 Board Meeting

The following provides a status update for construction work performed within the Macomb Interceptor Drain Drainage District for the previous month.

Segment 5 Rehabilitation

Contractor: Oscar Renda

Engineering Consultant: FK Engineering

Project Description:

The Segment 5 reach of the Romeo Arm Interceptor is approximately 8,300 linear feet; it runs along 15 Mile Road starting at the ITC Corridor and extends east to approximately Hayes Road. The first 7,000 linear feet is 11-foot diameter non-reinforced concrete pipe, and the next 1,300 linear feet is 8-foot diameter steel reinforced concrete pipe. The rehabilitation consists of debris removal, cleaning, and inspection of the pipe's invert. Next, HOBAS pipe will be used to slip line 7,000 linear feet of the 11-foot diameter sewer and the 1,300 linear feet section of 8-foot diameter pipe will be coated with a corrosion resistant geo-polymer spray applied coating. To facilitate this work, a new control structure and access shaft is under construction in the ITC Corridor. The new control structure will provide the contractor access to the sewer to facilitate the work and will also serve as a dewatering pump station to draw down the upstream water level in the sewer.

Significant project tasks that have occurred over the past month:

- 1. Continued development, review, and approval of the required construction submittals.
- 2. Ground dewatering well maintenance and monitoring.
- 3. Continued spray-lining the 8-foot diameter interceptor (PCI-37) 1300 Linear feet total
 - Approximately 900 linear feet is completed (5 to 7 o'clock)
 - Approximately 850 linear feet is completed (entire circumference of pipe)

- Approximately 65% completed
- Weather & Maintenance Days significantly reduced work within the Interceptor this month.
- The Engineering team performed an inspection of the spry-lining this month; no significant issues noted.
- 4. Continued construction of the CS-12 permanent structure, which includes:
 - Installation of the flume grating.
 - Installation of the guide rails for the stoplogs.
 - Continued the installation of the pump piping and appurtenances.
- 5. Continued electrical work for the permanent CS-12 Pumps:
 - o Conduit installation
 - Pulling cables for pumps
 - Installation of termination boxes




Figure 3 – CS-12 Electrical Conduit Installation

Segment 6 Rehabilitation

Contractor: Ric-Man Construction

Engineering Consultant: FK Engineering

Project Description:

The Segment 6 Rehab project includes the rehabilitation of these main elements:

- 1. Cleaning and slip-lining (Hobas) of the 5-foot diameter 15 Mile Interceptor from MH-01 at Garfield Road and 15 Mile to MH-04 approximately 2200 feet east along 15 Mile.
- 2. Cleaning and slip-lining (Hobas) the 1400 linear feet 11-foot diameter Romeo Arm Interceptor sewer between CS-3 on 15 Mile Road and CS-2 on Garfield north of 15 Mile Road.
- 3. Rehabilitation of the Meter Facility FR-S-1 on Garfield south of 15 Mile Road.
- 4. Rehabilitation and spray-lining of the CS-2 and CS-3 control structure facilities. These concrete structures have been damaged by H2S damage over time and need repair.
- 5. Installation of an air-jumper to be incorporated into the existing Biofilter facility. This is being done to address the high level of odor issues that have resulted over the years from the intersection of 15 Mile and Garfield.
- 6. Installation of a new gate control structure on the 15 Mile Interceptor. This will allow for the rehabilitation of the MH-01 structure and provide future storage options within that interceptor.

The project started in September 2021 and is scheduled to be completed in June 2023.

Significant project tasks that have occurred over the past month:

- 1. The Contractor continues to develop and submit the required submittals to the Engineer & Owner for review.
- 2. Performed an inspection of the damaged HOBAS which appears to be in the same condition as previously observed.
- 3. Completed installation of the 54-inch HOBAS.
- 4. Started preparation for grouting of the annular space around the 54-inch HOBAS.
- 5. Installed the platforms and stoplog guides in the CS-13 Structure.
- 6. Continued installation of the mechanical and electrical appurtenances for the CS-13 Gate.
- 7. Completed flow control testing for the cleaning and HOBAS lining work between CS-2 and CS-3.
- 8. Continued preparing CS-2 for access to clean and slip-line between CS-2 and CS-3.
- 9. Wet-weather has impacted the available working days in the Interceptor this month.




Figure 8 – CS-13 Platform Installation




Figure 9 – CS-13 Platform Installation

Project Description: MCPWO identified 755 feet of 7-foot diameter pipe within the Garfield Interceptor that has been aggressively attacked with Hydrogen Sulfide damage. This stretch of pipe was immediately labeled as an immediate repair and MCPWO underwent an analysis of options for repairs. The selected option was a Spiral Wound PVC liner which has been installed around the world but is the first time being installed within Michigan. This product has a guaranteed useful life of 50-years and is being treated as a pilot project within the MID system.

Significant project tasks that have occurred over the past month:

- MA-S-2 flow bypass setup and running as needed.
- As of 3/18/23, Spiral Wound lining has been completed.
- Contractor is currently setting up to begin the grouting process for the Spiral Wound. This will be done over 4 separate lifts.
- Working with the contractor regarding submittals and scheduling for the change order portion of the project.

Interceptor Inspection Program

Contractor: Doetsch Environmental Services, Inc.

Engineering Consultant: Fishbeck

Project Description:

The 2020 sewer inspection program was awarded to Doetsch Environmental Services in November 2020. The inspection program includes inspection of approximately 26 miles of sanitary sewer, 360 manholes and other aspects of the sanitary sewage infrastructure across multiple drainage districts, including the MIDDD.

The MIDDD portion of the inspection program includes 101,335 linear feet (19.25 miles) of pipe ranging in diameter from 24" to 132" and 145 manhole structures. Additionally, inspection of 8 junction chambers and 8 Drop Shaft/Connecting sewers will be performed.

The inspection interval for the entire system is based on a 3-year cycle, where non-reinforced concrete pipe is inspected every 3 years and reinforced concrete pipe is inspected every 6 years. The 2020 inspection program is the largest ever performed by the Macomb County Public Works Office.

Significant project tasks that have occurred over the past month:

- 1. The Consultant is reviewing the data and preparing inspection reports. This is the final item to complete this project.
- 2. Doestch has finished all punch list work and the data is being confirmed by Fishbeck at this time. Waiting on them to submit their final invoice.

Phase II Grouting

Contractor: Doetsch Environmental Services, Inc.

Engineering Consultant: AEW

Project Description:

The Phase II Grouting project was awarded to Doetsch Environmental during summer 2020. The work includes chemical grouting of the sewer and manholes where infiltration is present. The work is planned in all reaches of the system not included in the Segment 5 or portion of the Romeo Arm rehabilitated during the 2016 Interceptor Collapse. The main areas of work include the Romeo Arm along Garfield Road between 15 Mile and Clinton River Roads, the Garfield Interceptor between Clinton River and 21 Mile Roads, and the Lakeshore Interceptor between the Clintondale Pump Station at 15 Mile and Union Lake and Joy Boulevard in Harrison Township. The chemical grouting is aimed to stop all active infiltration within the system in advance of future rehabilitation and maintenance projects.

Significant project tasks that have occurred over the past month:

- 1. The crew has not worked since late July 2022.
- 2. The critical area grouting is complete, grouting operations will resume in non-critical areas when daily flow control operations allow.

Odor & Corrosion Control Facilities

Contractor: L. D'Agostini & Sons

Engineering Consultant: Tetra Tech

Project Description:

The Macomb Interceptor Drain completed a system-wide odor and corrosion study to evaluate the need for additional odor and corrosion control facilities to mitigate corrosion induced degradation of the interceptor and nuisance odors emitting from the interceptor near homes, businesses and public spaces. This effort is concentrated on extending the useful life of the interceptor and reducing nuisance odors emitting from the interceptor.

The study identified the need to construct three new odor and corrosion control facilities. Additionally, it was determined that the existing open-bed woodchip media type Fraser Bio-Filter would be more efficient and effective if converted to an enclosed bio-filter with an engineered media. The locations of the new facilities were determined through analysis and computer modeling using data that was collected in the field during the study phase. The facilities are intended to complement one another to reduce hydrogen sulfide induced corrosion.

The facilities are summarized in the Table below:

The construction contract was awarded to L. D'Agostini & Sons in October of 2022 and the contractual Notice to Proceed was issued with an effective date of December 2, 2022. The number of days to achieve substantial completion is 630 days, resulting in a contractually required substantial completion date of August 23, 2024.

The construction work commenced in January of 2023 and is estimated to be completed by the summer of 2024. The estimated schedule for each site is summarized in the table below:

- 4. The Contractor completed the installation of SESC measures at all project locations.
- 5. The Contractor mobilized the Clintondale PS site:
 - a. Layout and Excavation for equipment pad foundations
- 6. The Contractor started to mobilized the 21 Mile and Garfield and Fraser sites.

The expiring annual premium was \$210,613. The renewal offering has increased \$19,232 or 9.13%. Last year, Terrorism Risk Insurance was included (optional coverage). Premium is not subject to annual audit.

The liability premium is based upon expenditures. Last year ('20/'21) an amount of \$72,638,830 was reported. This year, ('21/'22) an amount of \$79,527,750 was reported. The '21/'22 amount reflects an increase of \$6,903,920 or 9.51%.

Afforded liability limits are separate from each other. Payment of claims for one line of coverage will not affect or reduce the limits dedicated to the remaining lines of coverage. Please refer to policy forms for terms, definitions, conditions, and exclusions.

The deductibles apply to both the payment of claim adjustment expenses and third-party damage payments. Once the deductible is exhausted, the specific limit is dedicated to the payment of third-party damages alone; claim expenses are outside of the afforded limits. Argonaut requires the continued third-party administrator (TPA) relationship with the ASU Group or other approved TPA.

Argonaut has included their proprietary "360" endorsement which adds the following coverage enhancements to the General Liability: Blanket Additional Insured (when required by written contract, agreement, or permit). Broadcasting, Publishing, and Telecasting offenses are covered under Personal Injury. By separate endorsement, Limited Pollution Liability Coverage (extended for Property Damage under the General Liability policy – excludes Bodily Injury) is added for the reverse flow of sewage (endorsement GL-210 [07/00]).

As with the expiring contract, Argonaut is offering: 1) a traditional underlying and excess policy format. No impact on the afforded coverages: same carriers (underlying and excess), same claims and underwriting staff, and same occurrence limit of liability - \$11,000,000. 2) Covered claims are subject to a \$100,000 deductible. 3) The Public Officials' liability coverage is offered on a Claims Made policy form in lieu of an Occurrence form. A retroactive date of April 26, 2021 will apply to covered claims. 4) The excess liability policy does not afford excess automobile liability coverage; the proposed policy affords \$1,000,000 Hired & Non-owned Automobile Liability. The coverage is afforded by way of a Combined (Bodily Injury and Property Damage) Single Limit formant (as before). The afforded limit is provided per Occurrence with no aggregate restrictions (again, same as before). 5) The combined aggregate limit of liability for covered General Liability and Public Officials' Liability claims is \$11,000,000.

In addition to securing the afforded liability coverages, we continue to monitor additions or improvements to the districts' physical assets. We have been advised that no measurable changes

occurred over the past year. You will recall that all property insurance is secure under Macomb County's property insurance policy.
