



Mr. Franz presented the pipeline article that was submitted to Pipeline Magazine. The article is in regards to the new hike and bike path that is in Sterling Heights.

Mr. Bednar updated on the prairie grass project. We are scheduled this spring to work with the National Fish and Wildlife Foundation to naturalize the north part of the drain. Ms. Miller stated when this project starts we will be sending out a letter to all residents that back up to that area as they will have to move anything they have in our drain easements, such as gardens. Mr. Bednar stated that we will have to treat and prep the land to be able to plant the prairie seeds. We will do the first treatment and they will do the second treatment and the plantings.

Mr. Bednar next presented the Sustain Our Great Lakes program (SOGL) grant application for Sterling Relief Daylighting and Green Infrastructure Project Phase 2. This project continues the

redesign and retrofit of the Sterling Relief Drain corridor by creating an additional 1.5 miles of diverse native habitat from the upstream end of Nelson Park to west of Mound Road. The estimated price of the project is \$765,000. The amount requested from SOGL is \$382,500. We are asking for \$50,000 cash grant match funds towards the project.

A motion was made by Mr. Romano, supported by Mr. Santo to submit the SOGL Grant application for Phase 2 of the Sterling Relief Daylighting and Green Infrastructure Project and to authorize up to \$50,000 of grant match funds.

### Sterling Relief Green Infrastructure Establishment Update and Tree Installation

The slopes of the drain in the Phase 1 project area are looking beautiful with a profusion of late summer wildflowers. Many pollinators including monarch butterflies are enjoying the bounty. The buffer zones are slower to establish with native grasses but they are serving as intended and helping to keep mowers out of the pollinator growth however some encroachment and dumping of yard waste is still happening. Some noxious and invasive weeds are still competing in the bottom of the drain in the bioretention cells. Treatment will occur through the summer and the last seeding/planting will occur before the grant period ends October 31, 2023. In the past few years, spring and summer has been punctuated with long dry periods and fall has been a more efficacious planting time for successful establishment.

This project, funded by the United States Environmental Protection Agency (US EPA), also includes fabrication and installation of a series of gate modifications within the underdrain pipe to increase the frequency of bioretention inundation to increase stormwater capture. We are currently working with a contractor to finalize gate fabrication and expect the gates to be installed in September. At this time, it is not believed that an extension of the grant will be necessary.

During the first two weeks of August 2023, Green Macomb funded the purchase of 20 trees to help replace some that didn't survive the initial planting (tree installation is considered match). Staff was joined by DNR community forester Lawrence Sobson, who shared tips and suggestions for the ongoing health and maintenance of the existing and newly planted trees.

### US Fish & Wildlife Service Prairie Conversion

On July 11, 2023, the final of two treatments was applied to the western 0.8 miles of the Sterling Relief Drain before the USFWS contractor installed native prairie grasses and wildflower seeds. Some sprout will be evident before the end of this growing season but most will pop up next spring and then establish over the next two to three years.

### SOGL Grant Application for Sterling Relief Daylighting & Green Infrastructure Retrofit Phase 2

On behalf of the Sterling Relief Drain Board, staff submitted a full proposal to the National Fish and Wildlife Foundation (NFWF) for the Sustain Our Great Lakes program (SOGL) requesting funds for Phase 2 of the Sterling Relief Daylighting and Green Infrastructure Retrofit Project on April 23, 2023.

This second phase of the project extends from the western terminus of the drain west to Mound Road for a distance of 1.5 miles and will include habitat creation and bioretention to slow and filter the stormwater entering the drain from the 1,610 acre drainshed.

The amount requested from the SOGL grant is \$415,500 for a project estimated to be \$887,250. The most competitive applications have 50% match, which may come from cash and in-kind contributions. Match from federal sources does not count towards the 50% but indicates support of the project. Potential partners and sources of match include:

- City of Sterling Heights maintenance access/recreation trail construction
- Macomb County Planning & Economic Development (MCPED) cash for plantings
- Consumer's Energy Planet Award (administered by MCPED) trees and native plantings
- US Fish and Wildlife Service prairie restoration project

As a reminder, the Sterling Relief Drain Drainage Board pledged \$50,000 towards the completion of Phase 2 of the Sterling Relief Daylighting and Green Infrastructure Retrofit project.

The US Fish and Wildlife Service prairie restoration project funders are in support of the proposed project and will allow the restoration project to be tailored to complement the activities and outcomes.

We anticipate grant award announcements to be forthcoming as the funders previously announced the grant project period to begin September 1, 2023.



GLS Automotive is in discussion with Comcast for the purchase of their site on Van Dyke. There is an existing long-term lease agreement between Comcast and the Sterling Relief Drainage District for use/lease of the parking lot on the property owned by the drainage district. GLS Automotive will continue to honor the existing parking lot lease agreement terms with the drainage district. The original terms of the agreement state the tenant (Comcast) shall have the right to transfer, assign and convey all of the tenant's right and interest in the lease with the landlord's (drainage district's) consent, which consent shall <u>not</u> be unreasonably withheld.

The district's attorney has reviewed and approved this lease reassignment agreement which the Board Chair has signed. Language has been added to allow a possible future trail along the property should the City be interested in building one. The City requires special land use approval by GLS Automotive for the property and is working with the new owner to ensure there are landscape improvements on the property. Once final approval is granted by the City, GLS Automotive will sign the lease agreement.

#### ASSIGNMENT AND ASSUMPTION OF LEASE

Kennedy Boulevard, Philadelphia, PA 19103-2838, Attn: Real Estate Counsel.

### <u>RECITALS</u>:

WHEREAS, Pursuant to that certain Assignment and Assumption of Lease dated November 21, 2000 by and between Assignor and Bosc Automotive Realty, Inc., Assignor is presently the holder of the tenant's interest under that certain Lease dated October 17, 1995 (collectively, the "Lease") by and between Sterling Relief Drain Drainage District, a Michigan public corporation, and Assignor, as successor to Bosc Automotive, Inc., regarding certain property located in Macomb County, Michigan, as more particularly described on Exhibit "A" attached hereto; and

WHEREAS, Assignor and Assignee are parties to that certain Purchase and Sale Agreement dated April 18, 2023 (as amended, the "<u>Agreement</u>"), pursuant to which Assignor has agreed to transfer all of its right, duties, title and interest under, in and to the Lease to Assignee, and Assignee has agreed to assume all of Assignor's rights, duties, title, and interest under, in and to the Lease.

**NOW, THEREFORE**, for and in consideration of the covenants and agreements set forth in this Assignment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:

1. <u>Assignment</u>. As of the Effective Date, Assignor hereby assigns, conveys, transfers, and sets over unto Assignee all of Assignor's right, title, and interest in, to, and under the Lease.

2. <u>Assumption</u>. As of the Effective Date, Assignee hereby assumes and agrees to pay all sums, and perform, fulfill, and comply with all covenants and obligations, which are to be paid, performed, fulfilled, and complied with by the tenant under the Lease as of the Effective Date. Assignee hereby acknowledges that Assignor has provided Assignee with a full, complete, and correct copy of the Lease. Assignee acknowledges that the current rent is \$4,292.86 per month, and that pursuant to Section 3A of the Lease, the Landlord may adjust rent (but only upon ninety (90) days prior notice of the effective date of the rent adjustment) every three (3) years from the commencement date of the primary Lease Term using the Detroit/Ann Arbor Area Consumer Price Index, however no rent adjustment shall be in excess of ten percent (10%) in any one three (3) year period.

3. <u>Indemnification</u>. Assignee hereby covenants and agrees for itself, its successors, and assigns, to indemnify, defend, and hold harmless Assignor for, from, and against any liabilities, actions, suits, proceedings, or claims, and all costs and expenses, including, without limitation, reasonable attorney's fees, incurred in connection therewith, arising out of any performance (or failure of performance) by Assignee under the Lease on, from, and after the Effective Date. Assignor hereby covenants and agrees to indemnify, defend, and hold harmless Assignee for, from, and against any liabilities, actions, suits, proceedings, or claims, and all costs and expenses, including, without limitation, reasonable attorney's fees, incurred in connection therewith, arising out of any arising out of any performance (or failure of performance) by Assignee to indemnify, defend, and hold harmless Assignee for, from, and against any liabilities, actions, suits, proceedings, or claims, and all costs and expenses, including, without limitation, reasonable attorney's fees, incurred in connection therewith, arising out of any arising out of any performance (or failure of performance) by Assignor under the Lease prior to the Effective Date.

4. <u>Drain</u>. Assignee has been informed that the City of Sterling Heights and Landlord are collaborating on a concept plan for a potential future minimum 14 foot wide bike path through the Sterling Relief Drain in the City of Sterling Heights, the route of which may or may not traverse some portion of the southern portion of the Sterling Drain that is subject to this Lease. In the event this occurs, the Assignee and Landlord agree to reasonably cooperate with each other to permit the bike route right-of-way and installation of this bike route in a location and by a construction method that substantially minimizes the impact on the Assignee's use and enjoyment of the parking lot premises, and such agreed upon location and method will be subject to a future Lease amendment, to be in form and substance reasonably acceptable to Landlord and Assignee.

5. <u>Binding Effect</u>. This Assignment shall inure to the benefit of and shall be binding upon the parties hereto and their respective successors and assigns.

6. <u>Governing Law</u>. This Assignment shall be governed by the laws of the State of Michigan.

7. <u>Counterparts</u>. This Assignment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any party whose signature appears thereon, and all of which shall together constitute one and the same instrument. 


