

Subject: Alexander Drain Inspection - Request for Approval

The Alexander Drain is an enclosed stormwater drain located in the City of St. Clair Shores that extends from just east of I-94 to Jefferson where it discharges into the open-air canal. The drain was constructed in the early 1960's with class 1 RCP, ranging in diameter from 60-inch down to 21-inch. The majority of the drain extends along this stretch in between Alexander and Centennial streets, thought there are 5 branches as well. The map of the drain is attached for reference.

The request for approval for an inspection of this drain stems from two reasons:

- A potential sinkhole in the rear yard of 21209 Centennial
- The potential to utilize this drain for sewer separation


In order to properly inspect this drain we will have to construct a temporary bulkhead near Jefferson and dewater the pipe. This is a result of the drain typically holding 1-2 feet of water. When the potential sink-hole was observed, we evaluated the measures required to facilitate this inspection which was costly based on the inspection of an isolated area of the drain. However, after discussing this with the City's Department of Public Works it was determined that they had an interest in potentially using this drain to divert flow as part of a sewer separation initiative. This provided the opportunity to maximize the benefit to facilitate the inspection of the entire drain.

The MCPWO selected this project to be included in the ongoing Drain Match Program, where the Drain District and/or City contributes a portion of the cost for inspection or repair and the Drain Match Program provides the remaining portion, typically a 50/50 split.

The estimated cost to perform this inspection is \$150,000, which includes fabrication of a custom bulk-head, dewatering the drain, debris removal and disposal, CCTV inspection of main line and branches. The City of St. Clair Shores indicated they will contribute \$75,000 toward this project, which will be presented for approval to their City Council in September. The remaining 75,000 will be contributed by the County's Drain Match Program. This inspection does not allow for the repairs of any defects discovered, those will be addressed as discovered (if critical) or in a future project.

The recommendation is that the Alexander Drain Drainage District Board approve the Contract with Doetsch Environmental Services for the not-to-exceed amount of \$150,000.

Mr. Stockel,

Doetsch Environmental Services will provide necessary, confined space entry equipment, dewatering pumps, power units, bulkheads, hose / piping and labor to install pumps and dewater/inspect the Alexander Drain.

Dewatering of drain including bulkhead: \$39,885.00 Manned entry CCTV Inspection of pipe: \$4.00 per linear foot. Inspection of pipe: branches via tractored camera: \$2.60 per linear foot. Vacuum truck to vacuum fish during dewatering: \$9,000.00 Vacuum truck and jet truck to clean chamber at headwall: \$17,500.00 Disposal for non-hazardous debris: .75 per gallon Lab analysis of debris (TCLP): \$2,200.00 Disposal of hazardous debris: TBD

- Price assumes privacy fence can be re-used.
- Coordination with neighbors by others.
- Use of private property provided by others.
- Traffic permits on Jefferson provided by others.
- Does not include tree removal in backyard adjacent to headwall (not anticipated).

Dewatering: Includes pumps, bulkhead installation, turbidity curtain, crane to pull bulkheads during rain event. Initial pump down will take 12 hours and then maintenance pumping will begin. If a rain event occurs, pumping will stop and then resume during dry weather.
