The Macomb County Water Quality Board met on November 9, 2010. The Board passed a resolution opposing in principle any shipment of radioactive waste on the Great Lakes and also asking that the matter be referred to the Pipeline and Hazardous Materials Safety Commission.

Dr. van Hees of Wayne State University reviewed a study done with colleagues from Oakland University entitled "Distribution, sources and behavior of trace elements in the Clinton River Watershed, Michigan". The conclusion included that concentration levels reached levels similar to that found in known contaminated and larger watersheds characterized by heavy industrialization, urbanization and contamination.

Mr. Steve Gold, Director/Health Officer reported on the financial status of the Drinking Water Monitoring Project. Depending on the level of operations, funding could end from May to December 2011. To date, no substantial funding for long range continuation of the Project has been secured.

Mission: Monitoring, educational, investigatory and enforcement activities toward achieving the goal of all Macomb County surface waters being in compliance with Full Body Contact Standards.

Surface Water Monitoring: 60 sampling locations were monitored this month for *E. coli* indicator bacteria. The monitoring for October indicates that 73% of the sampling locations show improvement over the historical October data. See the attached data summary.

Bathing Beach Monitoring: Monitoring for the 2010-bathing season has concluded. Monitoring for 2011 will begin in April.

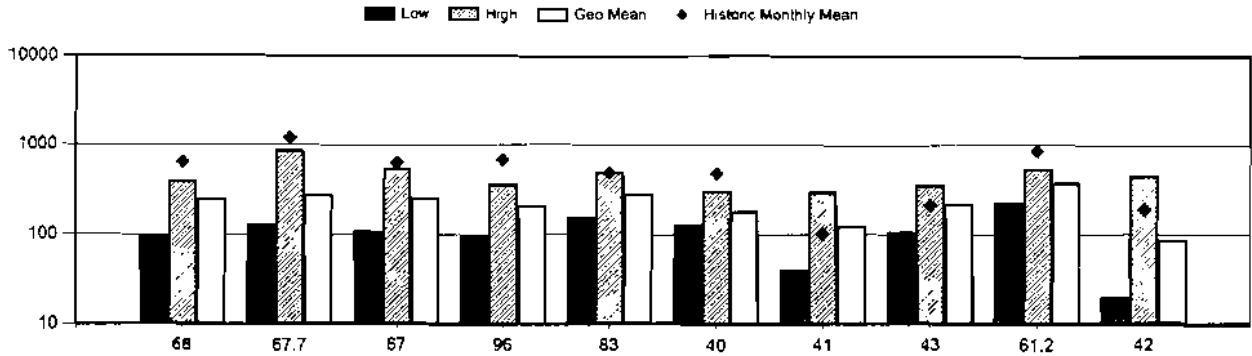

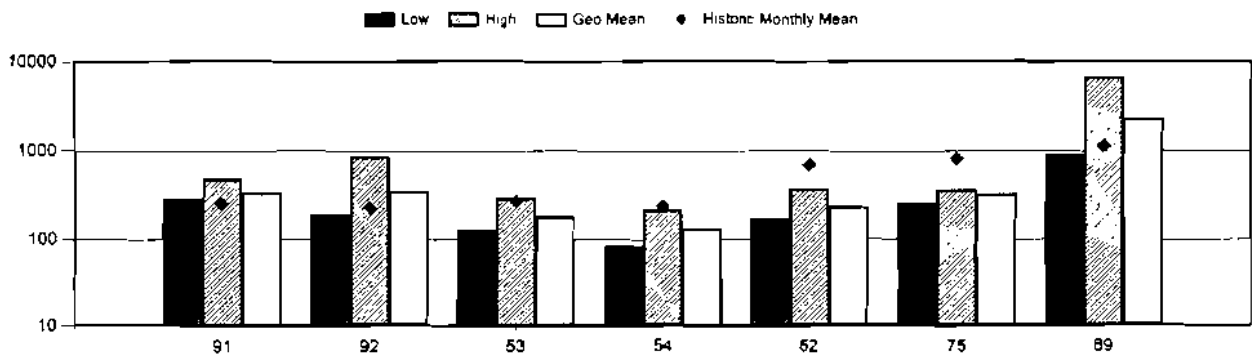

Clinton River Main Branch Watershed - West

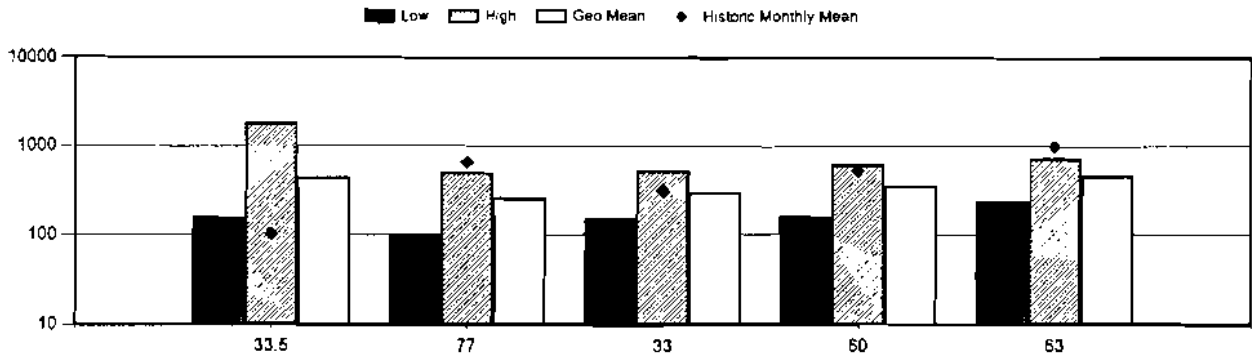

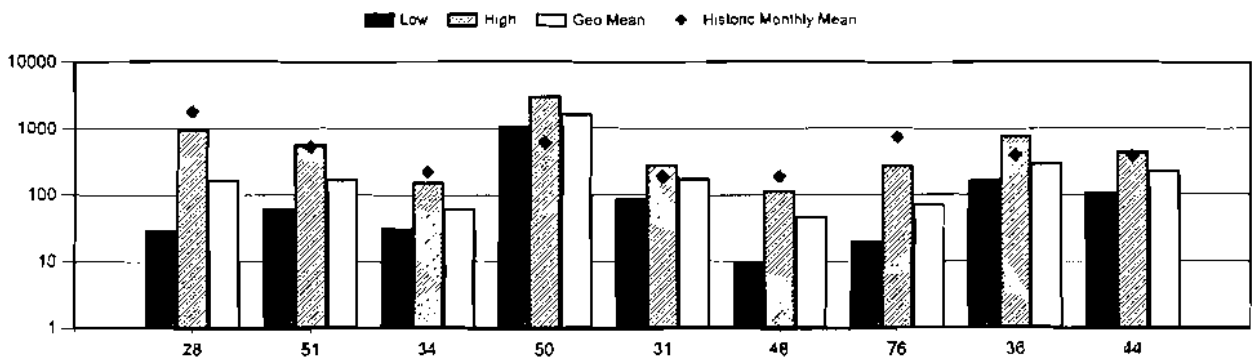

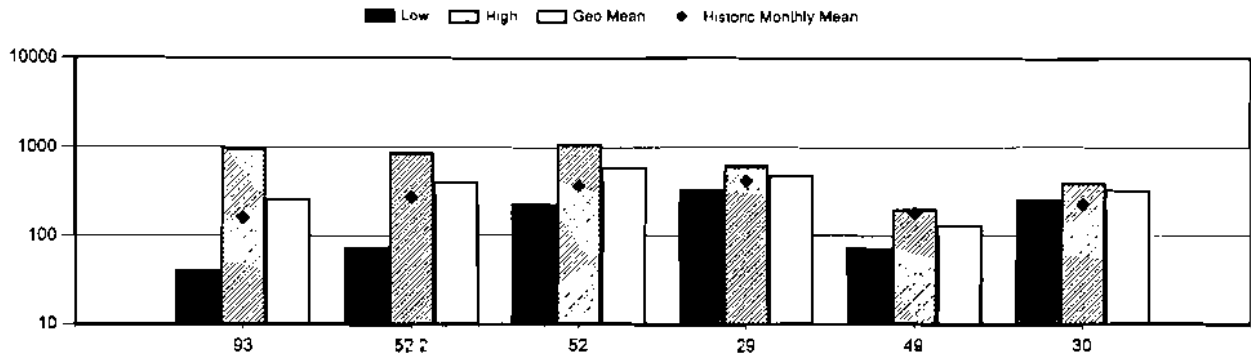

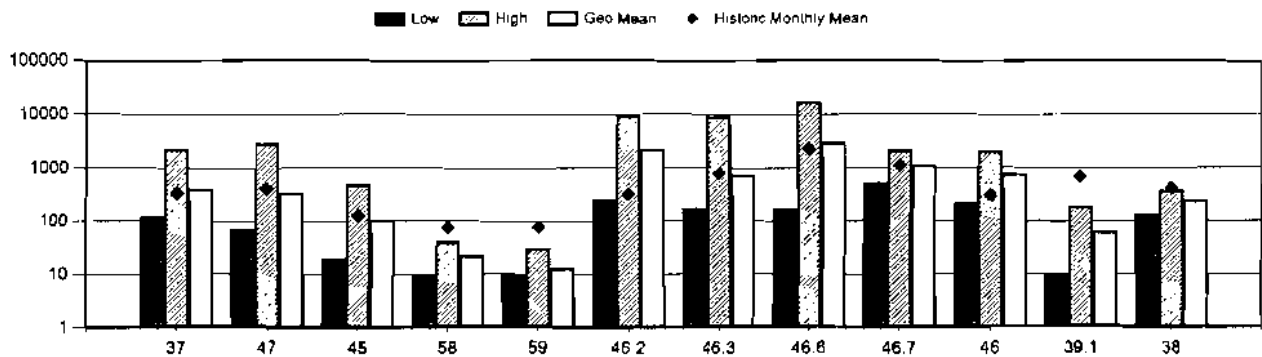

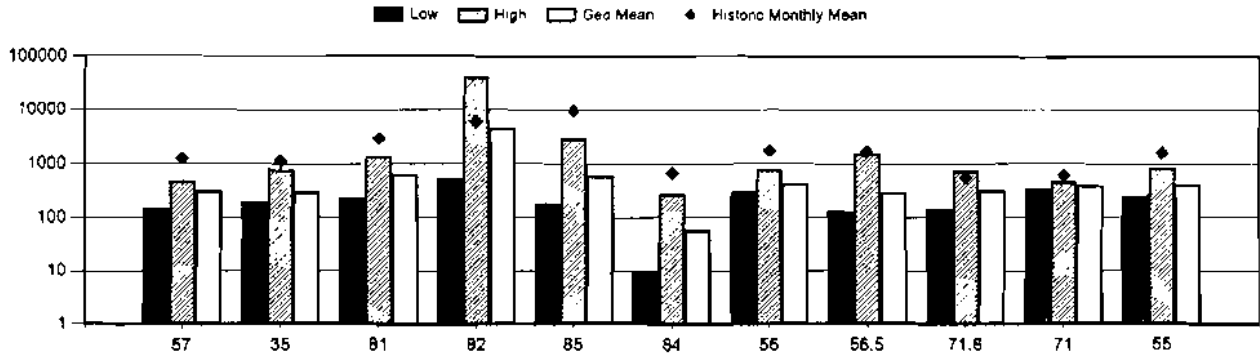
