## Man Who Fled from US Marshal's Arraigned

Mount Clemens, MI - Yesterday, 35 year old Dana Prieskorn of Mount Clemens was arraigned in connection with two separate incidents in two different cities in Macomb County this week.

It is alleged that on Monday, April 17, 2023 a few hours after Dana Prieskorn was bound over from Mount Clemens District Court on four felony charges, he entered his ex-girlfriend's vehicle and hid in her trunk. The victim entered her car after work in the Macomb County Parking Garage in downtown Mount Clemens. Once inside, the victim noticed items were moved, and opened the rear driver's side door. The defendant grabbed her and attempted to pull her in the vehicle, not allowing her to leave. The victim was able to escape and the defendant fled with her cell phone.

On Wednesday, April 19, 2023, Macomb County Sheriff's Department with the assistance of US Marshals attempted to apprehend Dana Prieskorn by using his GPS tether, which was a bond condition from his previous cases. Prieskorn allegedly fled in his vehicle when he saw officers approaching. Recklessly driving on 26 Mile Road in Chesterfield Twp., the defendant hit a patrol car, sending the patrol vehicle into a ditch sideways and rolling his truck in the process. Officers arrested Prieskorn without further incident.

Dana Prieskorn is charged with Attempted Unlawful Imprisonment (seven and half year felony,) Larceny of more than \$200 less than \$1,000 (one year misdemeanor,) and domestic violence (93 day misdemeanor) in the incident on Monday, April 17, 2023 with his ex-girlfriend. Magistrate Ryan Zemke sent the defendant's bond at \$250,000 cash/surety with a bond condition of having no contact with the victim. The Probable Cause Conference is scheduled for Monday, May 1, 2023 at 8:30 am in front of District Court Judge Jacob Femminio, Jr. and the Preliminary Exam has not been scheduled.

In the Wednesday, April 19, 2023 incident Dana Prieskorn is charged with Fleeing and Eluding a Police Officer (five year felony,) and assault with a dangerous weapon (four year felony.) New Baltimore District Court Magistrate Joseph P. Cozzolino set bond at \$100,000 cash/surety, no 10%. Prieskorn's Probable Cause Conference is scheduled for Thursday, April 27, 2023 at 9:00 am and his Preliminary Exam is scheduled for May 4, 2023 at 9:00 am in front of District Court Judge William Hackel III.

"This man is a violent threat to society and his actions show a total disregard for life and the law. Thank you to the Macomb County Sheriff's Department, Chesterfield Police Department and the US Marshals for apprehending this individual," said Macomb County Prosecutor Peter J. Lucido.
