## **Two of Three Women Arraigned in Connection with Home Invasion are Detroit Police Officers**

Mount Clemens, MI - Three women were charged and arraigned in April in connection with a home invasion in Roseville.

It is alleged that on Tuesday, April 11, 2023, Detroit Police Officer Brianna Cabano, Colleen Compton, and Detroit Police Officer Dayna Sears went to the victim's residence, also a Detroit Police Officer, and forced entry into his home. The three women destroyed and stole the victim's property.

Brianna Cabano (29) of Auburn Hills was charged with Home Invasion in the Second Degree (15 Year Felony), Home Invasion Second Degree Conspiracy (15 Year Felony,) Malicious Destruction of Property between \$1,000-\$20,000 (Five Year Felony,) and Larceny in a Building (Four Year Felony.) District Court Judge Alyia Hakim set a \$5,000.00 personal bond.

Dayna Sears (21) of Southfield was charged with Home Invasion in the Second Degree (15 Year Felony,) Malicious Destruction of Property between \$1,000-\$20,000 (Five Year Felony,) Larceny in a Building (Four Year Felony,) and Accessory After the Fact to a Felony (Five Year Felony,) District Court Judge Alyia Hakim set a \$5,000.00 personal bond.

Colleen Compton (29) of Warren was charged with Home Invasion in the Second Degree (15 Year Felony), Home Invasion Second Degree Conspiracy (15 Year Felony,) Malicious Destruction of Property between \$1,000-\$20,000 (Five Year Felony,) and Larceny in a Building (Four Year Felony.) District Court Judge Alyia Hakim set a \$5,000.00 personal bond.

All three women have a preliminary exam scheduled for Wednesday, June 14, 2023 at 8:30 am in front of Roseville District Court Judge Kathleen Tocco.

"As prosecutors, it is our duty to hold all individuals accountable for their actions, regardless of their profession or position of authority. The crime of home invasion is a serious offense and the fact that the defendants in this case are police officers only amplifies the severity of their actions. We will pursue justice with the utmost integrity and impartiality, ensuring that the law is upheld and justice is served for the victims of this crime," said Macomb County Prosecutor Peter J. Lucido.

The Macomb County Prosecutor's office represents the people. We are committed to achieving justice and following the laws of the State of Michigan. All that are accused of a crime are presumed innocent until proven guilty in a court of law.
