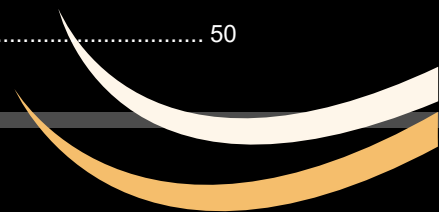

The Macomb County Sheriff's Office is committed to protecting the citizens of Macomb County, as well as those who work and visit our County. Our mission statement "Determined to keep your trust. Working to keep you safe." is exercised everyday by more than 524 men and women that are employed by the Sheriff's Office. There are many components of the Sheriff's Office, each one critical in providing effective service to the community, while keeping our citizens, neighborhoods and businesses safe each day.

The care and custody of inmates housed at the Macomb County Jail and service related to that care, custody and transportation of inmates make up over 70% of our budget and operations. The rated design capacity is currently 1,242 beds and we are near capacity on a daily basis. The staff that works in the jail are highly trained Correction Deputies who have to supervise a difficult population that are diagnosed with substance use and mental health disorders. Also challenging our staff are inmates that can't comply with our laws nor follow the rules of the Macomb County Jail. These facts do not deter our staff from reporting to duty and performing their responsibilities in the most exemplary way.

Our law enforcement component is comprised of highly trained Deputy Sheriffs and Dispatchers who handle 911 calls, respond to emergencies and request for services, investigate and prosecute crimes committed in Macomb County. We are the largest E911 dispatch center in Macomb County. Our consolidation with communities continues to result in increased effectiveness and efficiency. Our office also provides ancillary services in the areas of Auto Theft, Computer Crimes, Narcotics, Fugitive Apprehension and Major Crimes. We continue to use technology to our advantage and keep up to date with the ever changing trends in law enforcement to protect our citizens.

The Sheriff's Office is tasked with Court Security at the Circuit and District Court levels, as well as transporting incarcerated inmates to their court hearings throughout the County. Inmates are also taken to doctor appointments for treatment outside the jail and our court services section picks up prisoners arrested on warrants anywhere in the State. As you can imagine, the men and women in this unit drive thousands of miles a year while maintaining the safety and security of prisoners while on the road.

This Annual Report details our official statistical data and budgetary information to help us plan for the future, deploy our resources where they are needed, and most importantly be transparent to the public in all aspects of the Macomb County Sheriff's Office operations.

I thank each member of the Sheriff's Office for a job well done in keeping Macomb County safe.

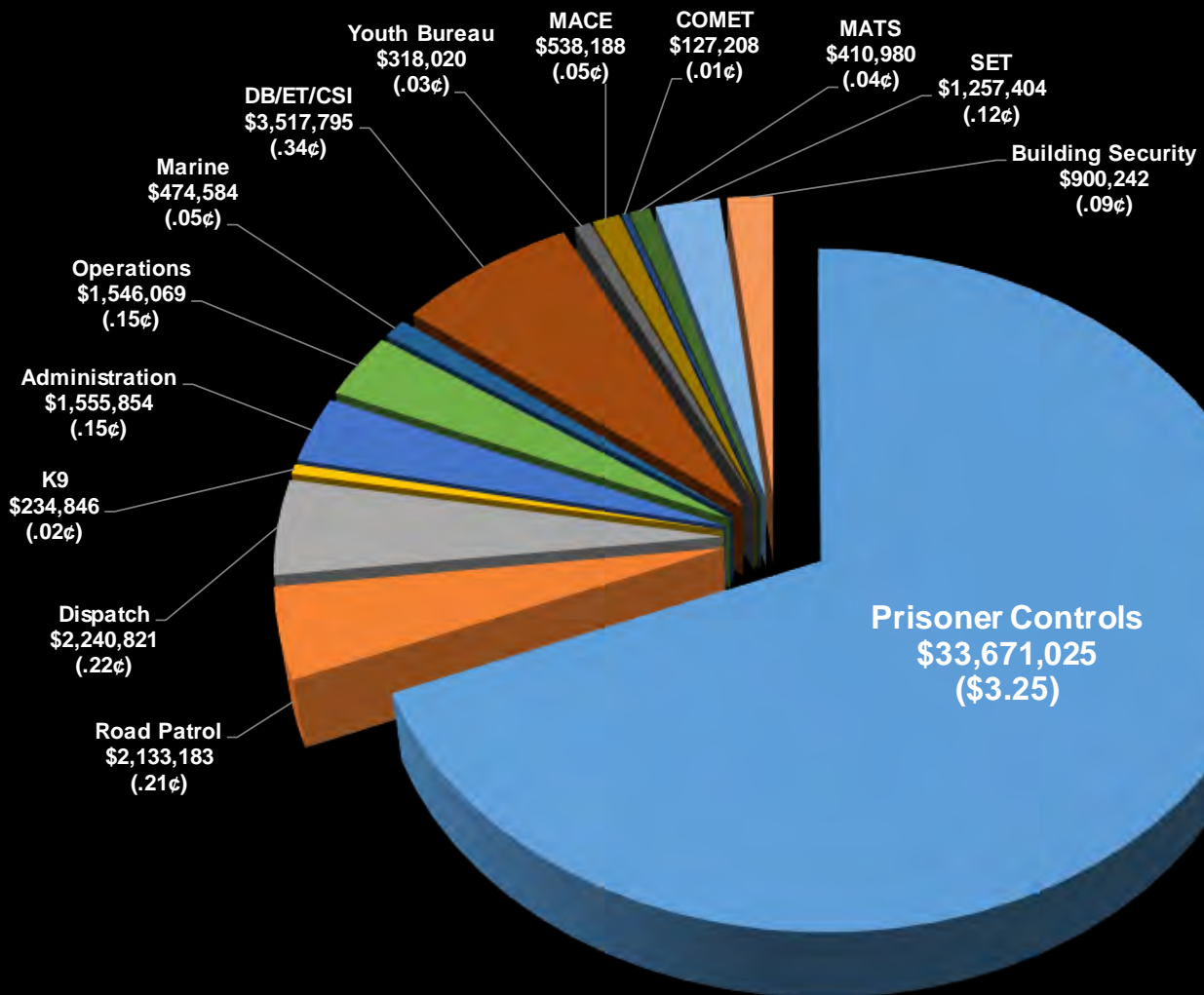

Sheriff's Office Budget

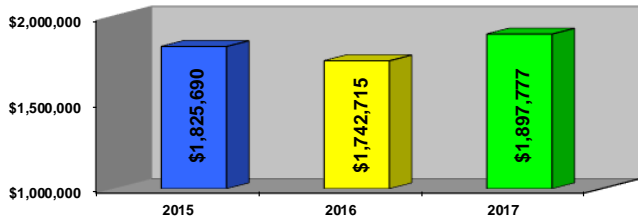
2017 Sheriff's Net Budget - By Unit

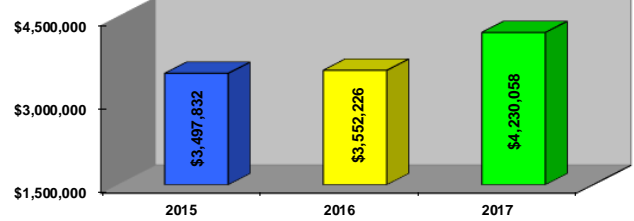

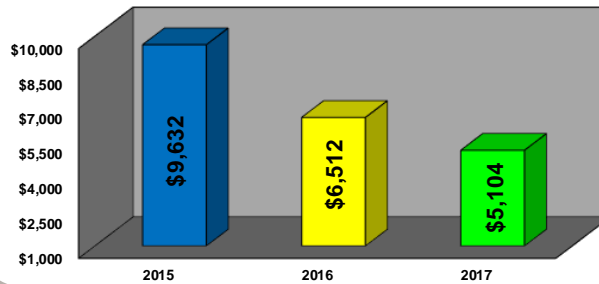

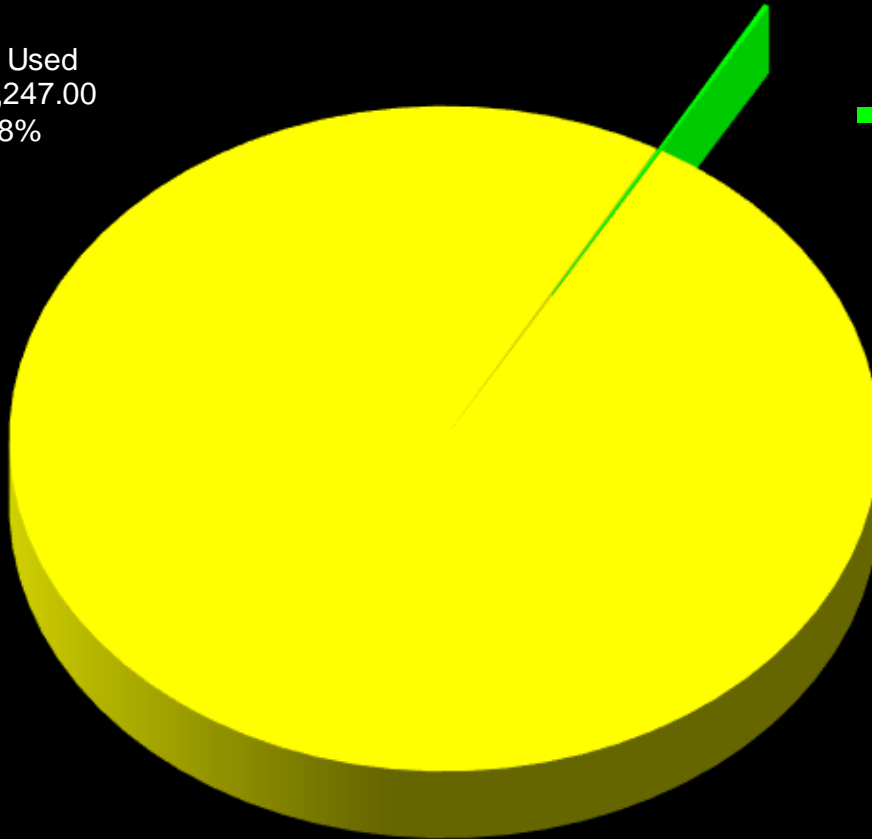

Jail Operations



Jail Operations

The Macomb County Jail is staffed by Deputies, Command Officers and support staff. These individuals are responsible for the care and custody of all prisoners, the well-being of staff, and maintaining security and order within the jail facility.

All courts through their Jail Bed Allocation plan and alternative sentencing assist in keeping the jail population below the design capacity. The jail's Rated Design Capacity is 1,242.

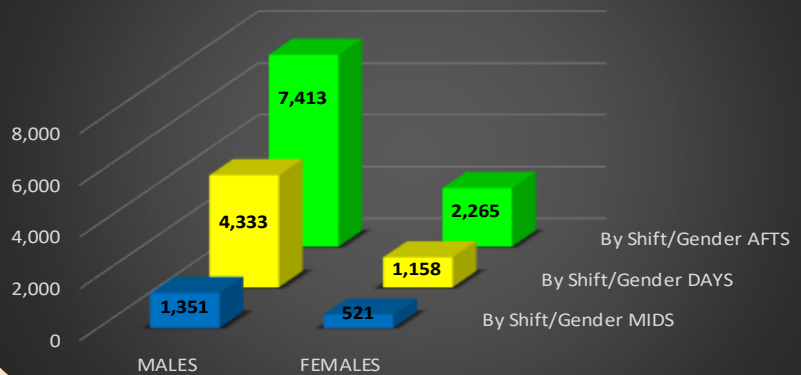


In 2017, a total of 17,041 new prisoners were booked into this facility. That number consisted of 13,097 males and 3,944 females. Of those booked, 39% were felony charges and 46% were misdemeanor charges and 15% were non public or miscellaneous.

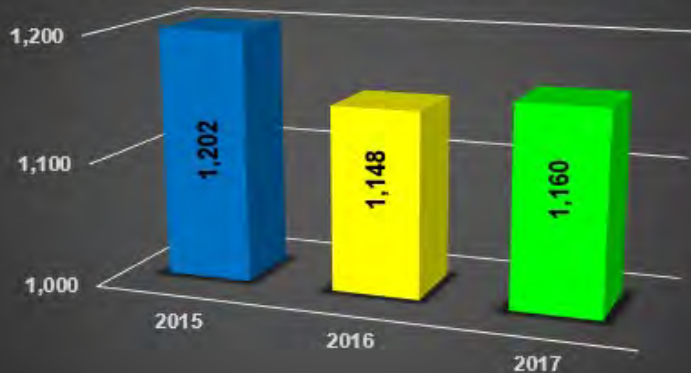

Prisoner Information

Our Jail Office staff is responsible for inmate tracking for bookings, releases, bonds, transports, court dispositions, sentences, and processing Sex Offender Registrations.

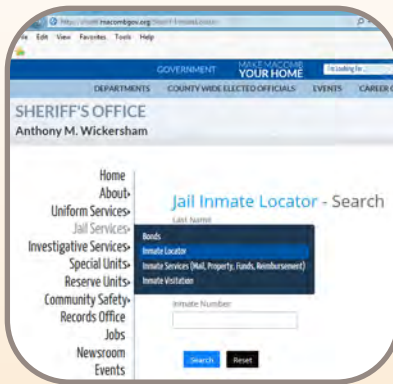
In 2017, our staff added 25,435 charges, disposed of 25,281 charges, updated court information on 32,618 inmate files, added 14,201 holds and added 7,477 sentences to inmate files.



They also handled \$1,486,527 in bond monies and collected \$3,050 in warrant collection fees.



The **Inmate Locator** application is available to the public allowing you to check on inmate status, bond information, and visiting information. It is accessible through the internet at the MacombSheriff.com website.



Video Visitation by ICSolutions is an innovative solution that provides an alternative to traditional, face-to-face inmate visitation in the Macomb County Jail.

Video visitation sessions provide added value and security to our facility by removing the necessity to transport inmates for traditional onsite visitations and allows friends and family members to conduct onsite visits from a kiosk in our jail's annex as well as offsite video visitation sessions from the comfort of the visitor's home using a personal computer or laptop.

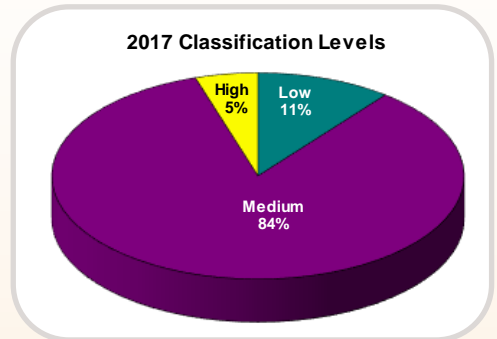

Classification Bureau



The Macomb County Sheriff's Office utilizes an objective classification plan to provide fair and consistent guidelines in determining prisoner assignments to housing areas, security level, treatment and program services. Original classifications and periodic reviews are performed to accommodate changes in charges, behavior, and to better align the jail population.



Prisoner Food Services

Continental Canteen provides food services for the Macomb County Jail. Prisoner trustees help with food preparation and serving. These services include basic meals and commissary sales. Meals cost approximately \$.99 cents per meal based upon the population count of inmates. Cost savings continue to be sought.

Prisoner Health Services

Correct Care Solutions Inc. provides medical, mental health, dental and related healthcare to inmates at the Macomb County Jail.

Some of the services include preliminary screening of inmates upon arrival, a comprehensive health evaluation, regularly scheduled sick call, 24-hour nursing coverage, physician visits on-site, hospitalization, medical specialty services and administrative support.

Approximately \$5.5 million dollars was spent in 2017 for prisoner healthcare.

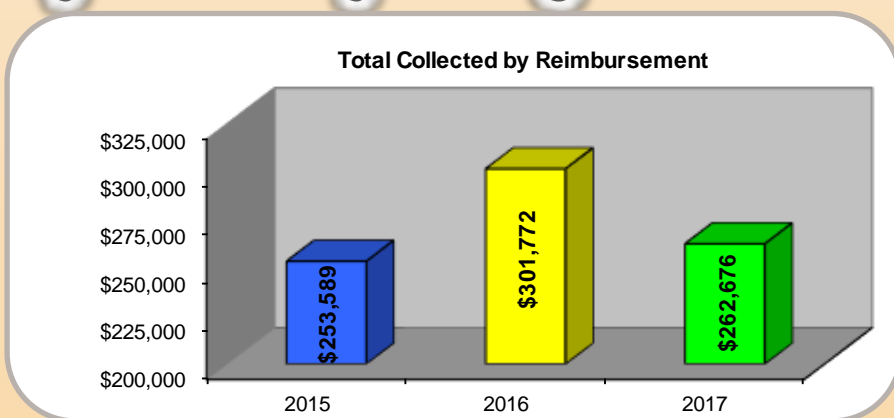

Prisoner Pay-to-Stay Program

In 1985, the jail reimbursement program (Pay-to-Stay) was implemented at the Macomb County Jail. The purpose of the program is to seek reimbursement from prisoners to help defray the cost of housing.

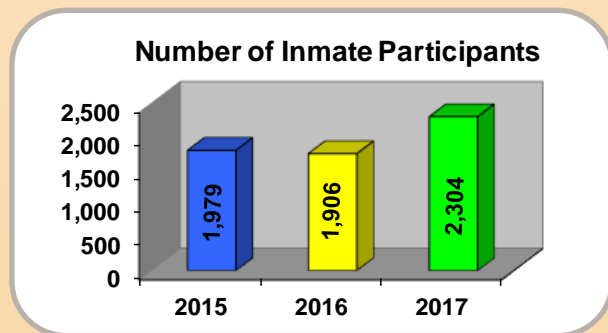

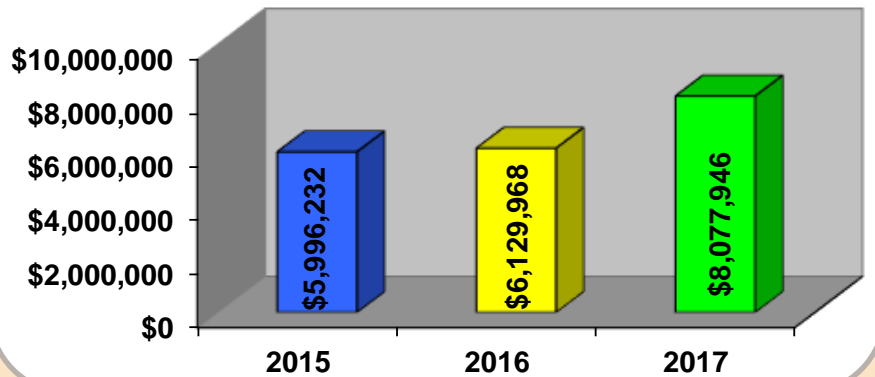


Mission Statement

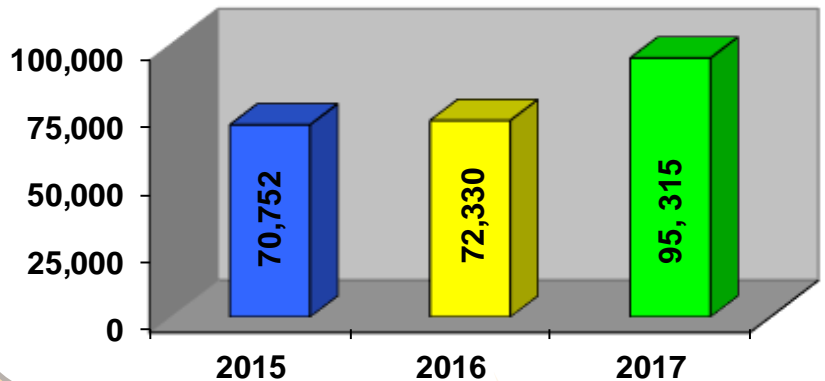
Macomb County Community Corrections mission is to provide effective, local, community-based alternatives to incarceration that promote public safety, hold offenders accountable, and improve their ability to live lawfully and productively in the community.

Macomb County Community Corrections is a community based sanction and rehabilitative program aimed at relieving prison and jail overcrowding through Court-approved sentencing alternatives. Non-violent offenders are placed into community sanctions, rather than in jail or prison, to allow for corrections space for more serious offenders. Rehabilitative and monitoring options include substance abuse inpatient and outpatient treatment, monitoring services, substance use testing, community service work, cognitive programming and pre-trial release supervision.

Mental Health Diversion

This diversion program is run by the Macomb County Community Mental Health Department and identifies Macomb County residents in jail, or out on bond, who have mental health problems.

The intent of this program is to link offenders with services and support outside of the jail to ensure that all aspects of their mental health treatment are being met.

Jail Ministry



The Macomb County Jail Ministry Team consists of 2 Clergy and over 100 Volunteers from various local denominations in the community.

In addition to 1,437 Clergy visits, the Macomb County Jail Ministry Team conducts regular religious services. During the year 2017, 1,304 worship services were conducted with 14,744 inmates attending.

The Ministry program also provides Bibles, clothing for released inmates, a book library, stamped envelopes, bus tickets and food certificates upon release. Christmas gifts are also distributed to prisoners and their children.



Uniform Services



Uniform Services Division



The Uniform Services Division includes a 911 Dispatch Center, Traffic Bureau, Court Security, Prisoner Transport, K-9, Marine Division, Dive Team, Liquor Control Enforcement, Reserve Deputies, and Fleet Management.

Eight communities contract with the Macomb County Sheriff's Office for 24/7 police services and/or dispatch services.

Emergency response is provided in four townships that do not have police departments. They are Armada, Bruce, Ray and Richmond Townships.

The Sheriff's Office also responds to any nearby local, state or federal agency which requests assistance.

The Honor Guard's mission is to enhance the professional image of the Macomb County Sheriff's Office, and the County of Macomb. The unit's first priority is to honor and pay respects to fallen Officers and their families. Every year they have continued to honor our own fallen officers by participating in wreath laying ceremonies honoring their sacrifice for their communities.

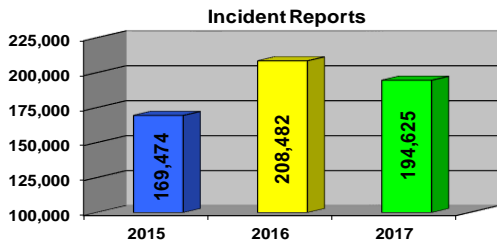
The 16 Honor Guard members dedicate their personal time to attend funerals and memorial services for our Brothers and Sisters in Law Enforcement, Fire Services and EMS that have lost their lives protecting and serving our citizens and our communities.

In 2017, the Honor Guard completed 15 details including National Law Enforcement Memorial Week held every May in Washington D.C.

All of the financial support has come solely from Honor Guard Members, fundraising, and donations we receive from citizens.



Dispatch Center



Macomb County Sheriff's dispatchers provide dispatch services for law enforcement, emergency medical services and fire emergencies. These calls include 911 emergency calls, crimes in progress, traffic issues as well as general assistance to citizens in the community. The dispatch center also provides dispatching services to coordinate multi jurisdictional efforts among various agencies in the county.

Dispatch services are provided for twelve communities, eleven fire departments and one emergency medical service. In 2017 dispatchers handled 323,861 total calls.



In 2017, five work consoles were added to Dispatch. The Macomb County Sheriff's Office will be the backup center for Warren Police Dispatch. Warren Police is also in the process of adding consoles to their Dispatch in order to be our backup center.



Funding has been approved from the State of Michigan for SMART 9-1-1. Those who have a physical disability, restrictions, medical conditions, pet alerts, building response plans for businesses, and emergency contacts. SMART 9-1-1 Connect enables to deliver data direct to our 9-1-1 center. Information can automatically be given to the call taker when someone uses this feature on their phone. Dispatchers can also text callers with this program.

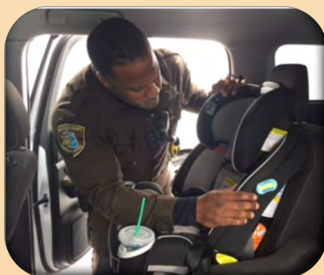
Sergeant responsibilities include scheduling, collecting traffic statistics, radar trailer deployment, tracking vehicles and traffic equipment. The Sergeant also attends numerous seminars, traffic related meetings with various organizations as well as managing and applying for all grants.



This year, Macomb County secured \$185,000 in state grant monies from the Office of highway Safety Planning compared to \$235,918 in 2016. This money was used for seatbelt enforcement, impaired driving enforcement, speeding enforcement, red light enforcement and distracted driving enforcement campaigns throughout the year.

During 2017, our agency processed approximately 3,538 vehicles of which 467 went to auction. Every vehicle abandoned or towed by sheriff personnel and not redeemed by the vehicle owner is processed by a certified deputy. In addition, 5 salvage vehicle inspections for residents of our contracted patrol areas were conducted.

In 2017, approximately 10 school bus violations were issued and 39 child seat inspections were performed.

Two deputies are certified to conduct Motor Carrier inspections and answer complaints from the Macomb County Road Commission and local agencies to assist in enforcing motor carrier laws throughout Macomb County when requested. One of these deputies is also federally certified and in addition to his daily patrol duties, conducted 34 Level I truck inspections.



Underage Drinking Enforcement

Macomb County Sheriff Office conducted countywide decoy operations at establishments that sell alcohol to the public to ensure that clerks check identification before selling alcohol. Our goal was to educate the businesses on the importance of checking patrons for identification when they are younger adults to prevent drinking related crimes and tragedies with underage customers.

An Office of Highway Safety Planning grant for \$19,952 was secured for this underage drinking enforcement.

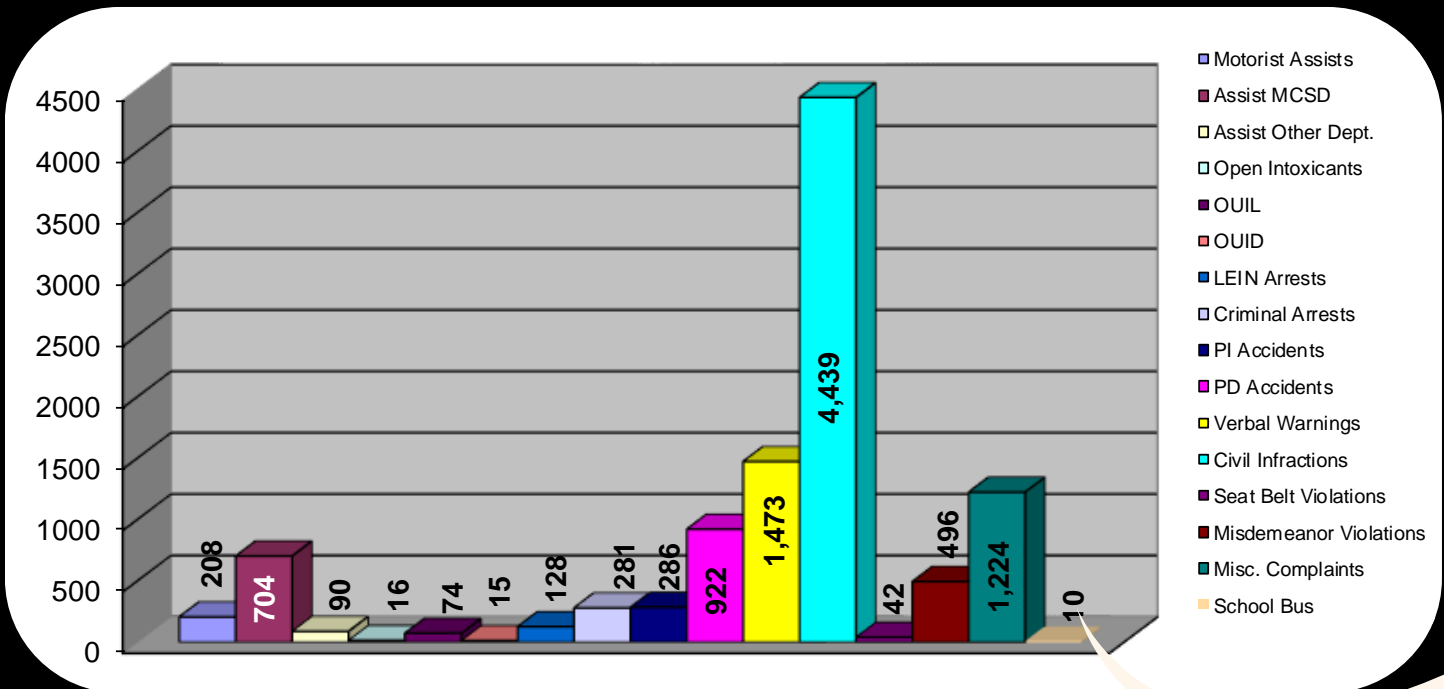


In 2017, The Traffic Bureau secured \$481,089 from the Office of Highway Safety Planning for Secondary Road Patrol. This was the same amount of funding as 2016.



During 2017, the Traffic Bureau responded to and investigated 898 property damage crashes, 306 personal injury crashes which includes 2 fatal crashes, for a total of 1,224 traffic crash investigations. The Traffic Division investigated approximately 40% of the total crashes investigated by the entire Sheriff's Office. The Traffic Bureau issued 5,082 total combined violations, gave 1,473 verbal warnings and patrolled over 62,000 miles on Macomb County Roads during 2017.

Canine Unit (K-9)

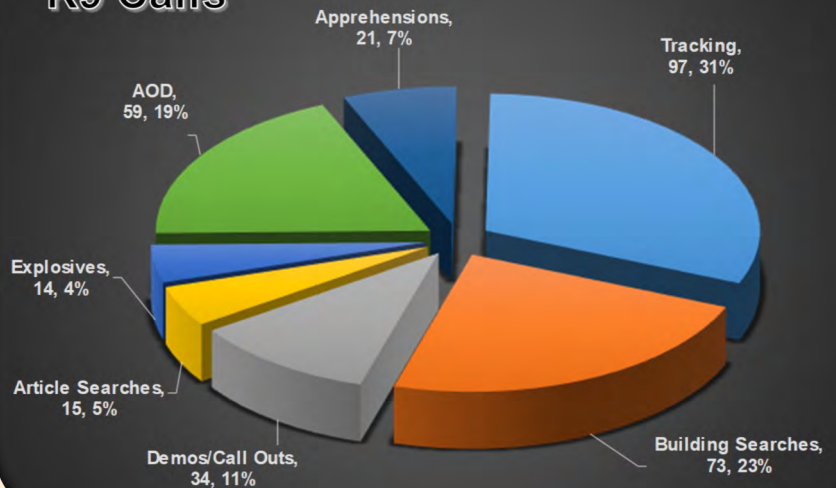


The K-9 Unit has proven to be an effective resource for us as well as for local, state, and federal agencies which we assist.

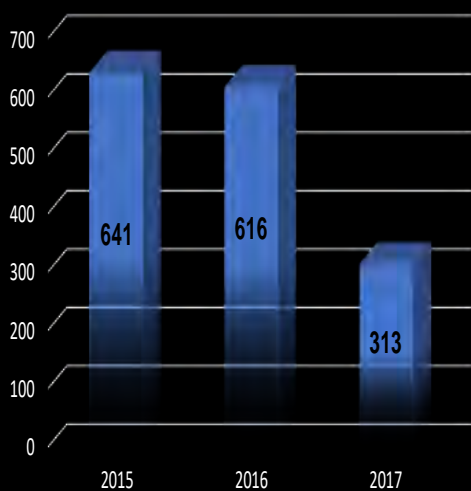
K-9 teams are utilized to locate lost persons, track suspects from crime scenes, locate drugs, suspects that are hiding, building searches, locating explosives, etc.

Marine Division

The Macomb County Sheriff's Marine Patrol strives to keep everyone safe on the waterways of Macomb County through education and enforcement.

The Marine Division patrols Lake St. Clair, which has been called the busiest freshwater lake in the world. Lake St. Clair covers approximately 85 square miles with 30.5 miles of shoreline connecting to 57 miles of rivers and streams.

The Sheriff's Marine Division is responsible for enforcing Michigan Marine law, investigating boat accidents, conducting livery inspections, search and rescue operations, ice rescues, body recovery and instructing safe boating classes. Working with the assistance of a large number of volunteer Marine Reserve Deputies allows us to meet those responsibilities. The division also works with federal agencies to assist in Border Security.

Boater's Safety Instruction

The Marine Division teaches the state approved boater's safety course "Boat Michigan – a course on responsible boating". During the winter months our deputies are primarily in the seventh grade classes, teaching boaters' safety at both public and private schools. Our marine reservists teach the same classes in the evenings to adult learners. In 2017, the Marine Division instructed 5,073 students on boating safety. Macomb County leads the state in the amount of boating safety students we teach every year.

Dive Team

The Macomb County Sheriff's Underwater Search and Recovery Team (MCSO USRT) is tasked with the recovery of evidence and persons. The team is comprised of 19 members. The Macomb County Sheriff's Office Underwater Search and Recovery Team is the only active member in the Urban Areas Security Initiative (UASI), from which funding was obtained for training.

The MCSO USRT trains once a month in several different types of environments. A new specifically designed watercraft outfitted for diving operations was purchased through the Port Security Grant funding. This funding also purchased a new sonar console and towfish.



The MCSO USRT was called out twice in 2017. These call outs were for body recoveries and on both occasions recoveries were made within the first 24 hours. MCSO USRT has had a 100% success rate in recoveries for several years and strives to continue with this success rate.

Court Security

The Macomb County Sheriff's Office Court Security Division is responsible for providing safety and security to the judges, courthouse staff, lawyers, inmates, and public. This also includes security for the offices of the County Commissioners, Prosecutors, and Treasurer's Office, Fiend of the court, Probate court, Old County Building, Reimbursement, Probation Department, and other ancillary offices of Macomb County within the locations listed above.

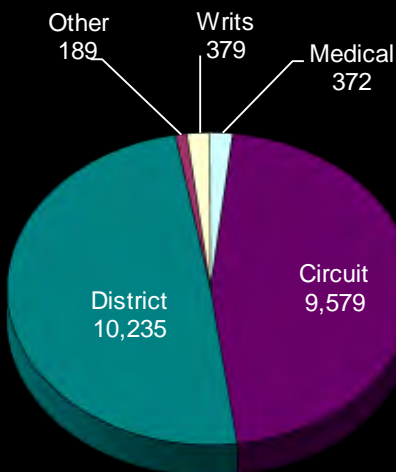
It is the duty of the Protective Service Officers to screen the public for any items that could be considered weapons when entering the county buildings. In 2017, an X-Ray machine, a walk through metal detector and two hand held metal detectors were purchased.

A Deputy Sheriff is assigned to each Judge to maintain order in the courtroom. Each Deputy is trained in Emergency Responses such as building evacuations, bomb threats, barricaded gunman or hostage situations, first responder to an "active shooter" situation, crowd control and first aid (CPR/AED).

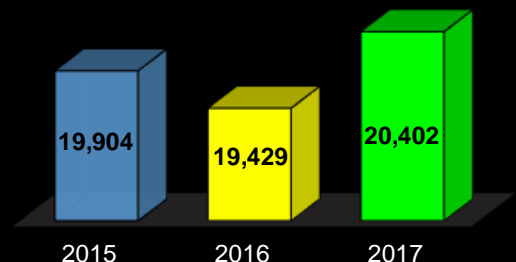

The Sheriff's Office is also responsible for the transporting of inmates to the District Courts and the 16th Circuit Court for arraignments, trials and sentencing.

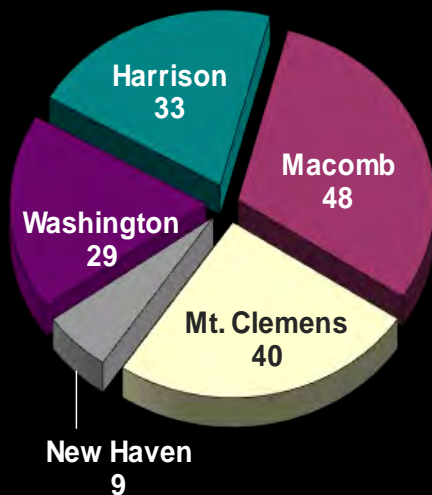
The District Courts include 37-B Centerline, 41-B Clinton Township, 38th Eastpointe, 42-2 New Baltimore, 42-1Romeo, 39th Roseville, 41-A Shelby Township, 40th St. Clair Shores, 41-A Sterling Heights, and 37 -A Warren. Other prisoner transports include but are not limited to hospitals, prisons, in and out of state warrant pickups, and psychological testing centers. In 2017, approximately 237,000 miles were logged by the Prisoner Transport Division.

PRISONER TRANSPORT BY YEARS



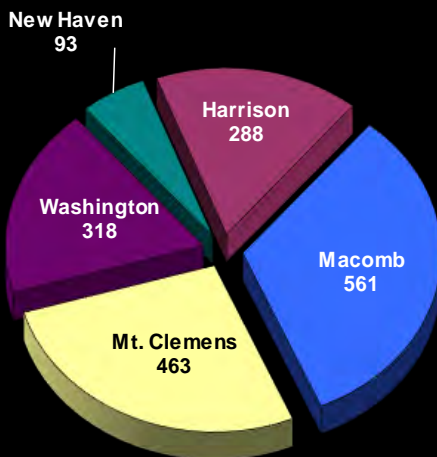

The Macomb County Sheriff's Office, under the authority of PA 58 of 1998, enforces the provisions of the statute of the Michigan Liquor Control Code. The responsibilities granted to the sheriff include:

- 1) Inspections of licensed establishments.
- 2) Conducting criminal background checks on all new and transfer liquor license applications.
- 3) Ensuring that the building housing the licensed establishment meets local code.
- 4) Granting special one-day liquor licenses.
- 5) Conducting investigation at licensed establishments targeting the sale and consumption of alcoholic beverages by minors.

In addition to the duties assigned to deputies in our patrol areas, they also conduct inspections of licensed liquor establishments throughout the year. These inspections are done randomly and verify that the licensees are operating within the guidelines established by the Liquor Control Commission.

Sheriff's Office personnel also enforce the rules and regulations of the Michigan Liquor Control Commission by targeting the illegal sale and consumption of alcohol to minors. Business establishments selling alcohol to minors are issued citations which are forwarded to the MLCC for sanctions against the licensee and business.

Warning to Minors



A minor shall not purchase or attempt to purchase alcoholic liquor, consume or attempt to consume alcoholic liquor, possess or attempt to possess alcoholic liquor, or have any bodily alcohol content. A minor who violates this law is responsible for a state civil infraction upon the first offense. A second offense raises the penalty to a misdemeanor. MCL 436.1703

Detective Bureau

The Detective Bureau conducts investigations for the Townships of Armada, Bruce, Harrison, Lenox, Macomb, Ray, Richmond and Washington; the City of Mt. Clemens and the Village of New Haven.

The Bureau consists of four supervisors, eleven detectives, and two clerical staff. In addition to their everyday supervisory duties and handling sensitive investigative cases, these supervisors also oversee the Crash Investigations Unit (C.I.U.), Evidence Technician Unit, Youth Bureau, and Friend of the Court Enforcement Unit.

The Detective Bureau investigated a total of 3,769 cases in 2017 as compared to 3,650 in 2016.

In 2017, a new procedure was put in place to improve employment background investigations. A pre-interview panel sits with potential candidates to determine if they should move forward in the background process. 256 pre-interviews were conducted with candidates who applied for the positions of dispatcher or correctional deputy. 191 full investigation backgrounds were completed in 2017.

Friend of the Court (F.O.C.)

Five Deputies are assigned to the FOC enforcement unit. This unit works in conjunction with the Friend of the Court office to enforce support orders by the court. There are two teams of two deputies each that actively pursue and arrest those who fail to make child support payments and subsequently have bench warrants issued for their arrest.

The fifth deputy is assigned to work in the Friend of the Court office in the Old County Building. Friend of the Court enforcement deputies affected 3812 arrests/resolutions for bench and other arrest warrant for failure to pay child support in 2017. The total amount of arrearages accounted for by those arrest equals \$25,103,837.00.

Youth Bureau Services

Three personnel are assigned to the youth bureau. Consisting of one deputy investigator assigned primarily to youth investigations within the detective bureau, one deputy D.A.R.E. officer and one deputy school liaison in the Chippewa Valley School District. All detectives are cross trained to handle youth investigations.

The Youth Bureau handled 332 investigative complaints in 2017. This compares to 290 investigative complaints in 2016 which represented an increase of 42 cases in 2017.

The school liaison deputy is based out of Dakota High School and serves as the first line of enforcement in the school. He also is responsible for this Chippewa Valley School District "campus", where the daily population is over 3,000 people not including visitors.

The Drug Abuse Resistance Education (D.A.R.E.) deputy provides D.A.R.E. education to students in the Chippewa Valley, Mt. Clemens and Utica School Districts, in addition to four private schools. Approximately 1,400 fifth grade students from 14 different schools graduated from the program in 2017.

D.A.R.E. is a 10 week curriculum taught one day a week in each class and then there is a graduation ceremony. Students are awarded for participation and for their individual accomplishments.

D.A.R.E. classes focus on:

- Alcohol and drug awareness
- Healthy decisions
- Identifying and resisting peer pressure
- Bullying
- Cyber-bullying
- Internet safety and social media safety
- Texting/Sexting
- Prescription and over the counter drug abuse
- Inhalant abuse
- Taking charge of one's own life

Crash Investigations Unit (C.I.U)



The crash investigation unit (C.I.U.) is comprised of five Deputies and one Sergeant. The unit's primary function is to investigate fatal crashes or serious injury crashes likely to result in a fatality. The unit is also responsible for the reconstruction of all crashes resulting in criminal prosecution. Additionally, the crash unit is responsible for insuring that all evidence is documented, photographed, and collected so a thorough investigation and/or reconstruction can be completed. The crash unit documented 16 scenes that included 6 fatalities in 2017. Out of the 16 scenes the crash unit completed 5 full reconstructions.

Evidence Technicians



Although deputies assigned as evidence technicians may assist in handling calls for service, their primary role at a crime scene is the collections, preservation and processing of evidence. Macomb County Sheriff's Office evidence technicians not only function in that capacity of the Sheriff's Office, but also assist other local law enforcement agencies as requested. This year, 21,205 items were taken into the property room.

Polygraph



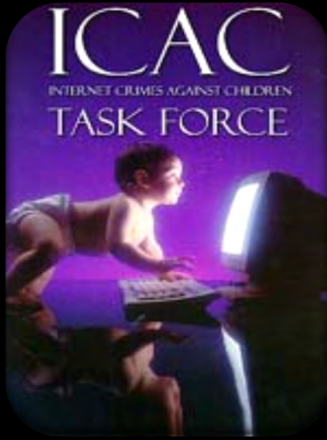
One deputy is assigned as a polygraph examiner to conduct polygraph examinations for the Sheriff's Office as well as other local police agency investigations. In 2017, 245 polygraphs were scheduled of which 103 were conducted. These polygraph examinations resulted in 49 that were deemed to have "deception indicated", while 45 were deemed "no deception" and 9 inconclusive.

A total of 22 confessions or admissions were obtained as a result of either pre or post-test interviews.

Macomb Area Computer Enforcement (M.A.C.E.)



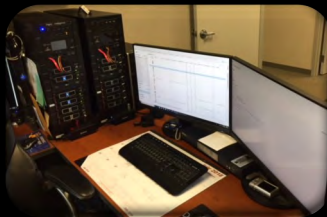
The Macomb Area Computer Enforcement unit (M.A.C.E.) is a computer crime task force assigned to investigate computer crimes such as computer fraud, identity theft, and child sexual exploitations. This year, the unit opened 623 cases and arrested 27 subjects for various criminal activities.

Computer crimes are often difficult to investigate do to crossing jurisdictional lines, as well as the increase in communication technology available: such as smart phones and on-line games through which children are solicited. M.A.C.E investigators assist other local law enforcement agencies with computer crime investigations.

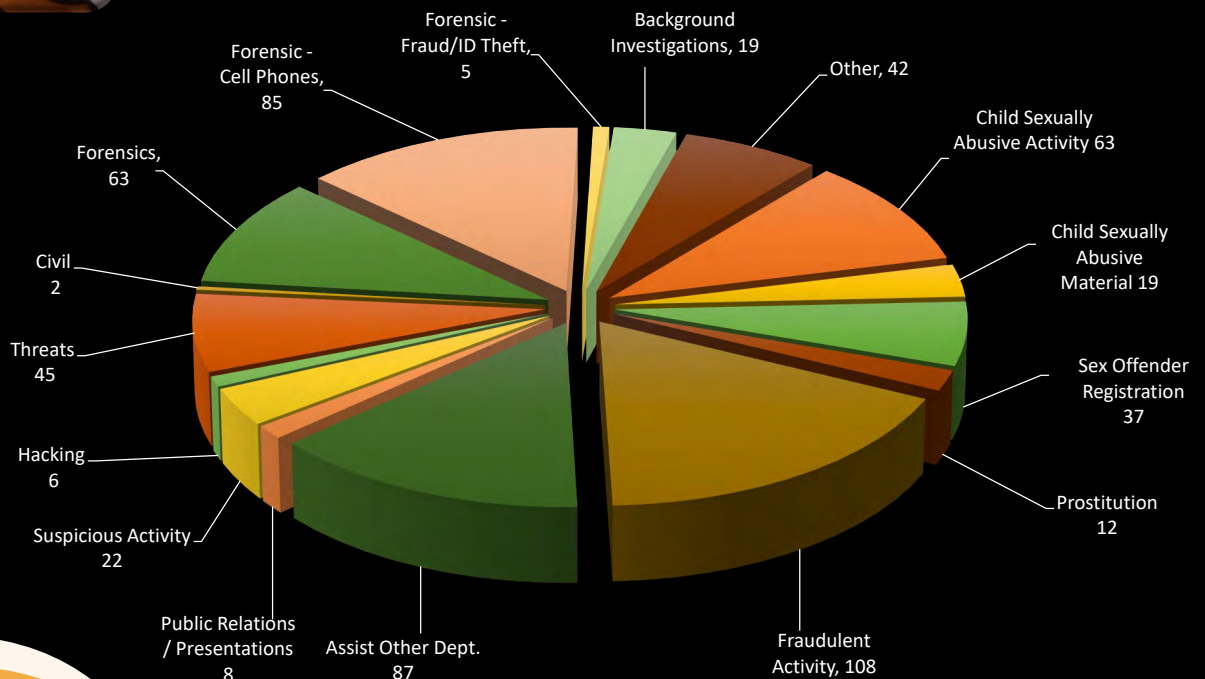

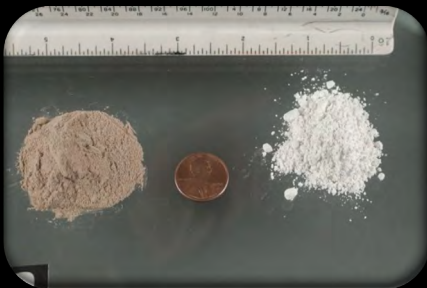
M.A.C.E. continues to assist with education and prevention endeavors in local schools educating all grade levels of students, teachers and parents regarding cyber crime and safe use of the Internet.



M.A.C.E. Investigations Activity



Sheriff Enforcement Team (S.E.T.)



The Sheriff's Enforcement Team (SET) provides undercover police services working under the authority of Macomb County Sheriff Anthony Wickersham. Detectives assigned to SET conduct narcotics related investigations, apprehend fugitives, conduct surveillance, and investigate high profile cases which may include homicide, robberies, residential break-ins and assaultive crimes.

During 2017, the SET Unit investigated more than 1,300 cases and executed 68 search warrants. These investigations resulted in 326 arrests, which included multiple child sexually abusive activity cases, human trafficking, narcotics cases, homicide, home invasions, armed robberies, and violent felony warrant arrests.

The SET Unit seized and forfeited \$411,321.98 in cash and auctioned property.

Drug Enforcement Agency (D.E.A.)



The Sheriff's Office continues to assign personnel to the Drug Enforcement Agency (D.E.A.) teams to investigate large scale drug traffickers which has resulted in taking millions of dollars of illegal narcotics off of the streets in our communities.

Fugitive Apprehension



Parole absconders, as well as those individuals with warrants for violent crimes, were targeted for arrest. In 2017, 226 such arrests were made. The United States Marshall's Office has provided some funding toward this in the form of a vehicle and funds for gasoline.

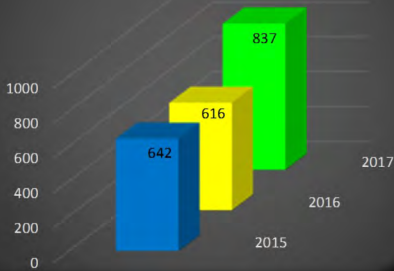


Sheriff's Office personnel are assigned to the County of Macomb Enforcement Team (C.O.M.E.T.), a multi-jurisdictional task force whose objective is to conduct drug investigations that cross jurisdictional boundaries. C.O.M.E.T provides assistance to agencies in major crime investigations. In 2017, C.O.M.E.T initiated 139 investigations and 67 arrests.

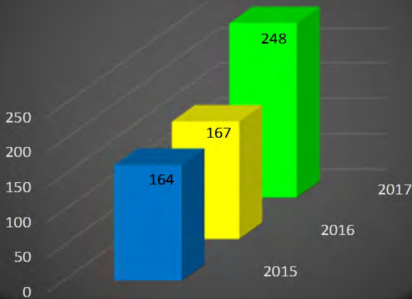


Macomb Auto Theft Squad (M.A.T.S.)

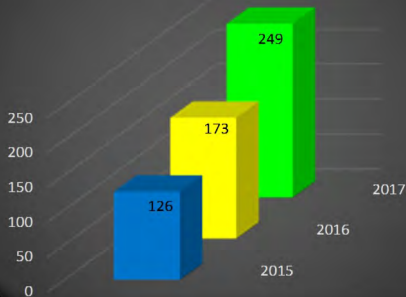
Cases Initiated by MATS

Vehicles Recovered by MATS

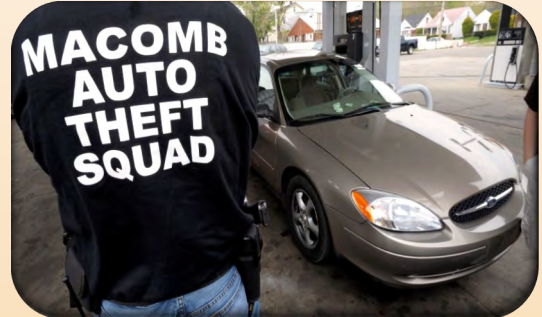


The Macomb Auto Theft Squad is a multi-jurisdictional task force comprised of investigators from the Macomb County Sheriff's Office, Centerline Department of Public Safety, Clinton Township Police Department, Roseville Police Department, Shelby Township Police Department, St. Clair Shores Police Department, Sterling Heights Police Department and the Warren Police department.

The Macomb Auto Theft Squad investigates auto theft and its related crimes including insurance fraud.

In 2017, MATS Detectives recovered approximately \$4,049,271.00 in vehicle recoveries which were returned back to the insurance companies and victims.

Special Weapons and Tactics (S.W.A.T.)



The Macomb County Sheriff's Office SWAT team is a multi-jurisdictional response unit which provides tactical support to any agency requesting assistance with high-risk situations. SWAT team members include law enforcement officers as well as medical personnel, and train on a monthly basis.

In 2017, the SWAT team took delivery of a Lenco BearCat armored vehicle which is used for training and all call out operations. The team's armored MRAP vehicle was also cosmetically, mechanically, and electrically updated.

The 23 member SWAT team responded to six calls for service in 2017.

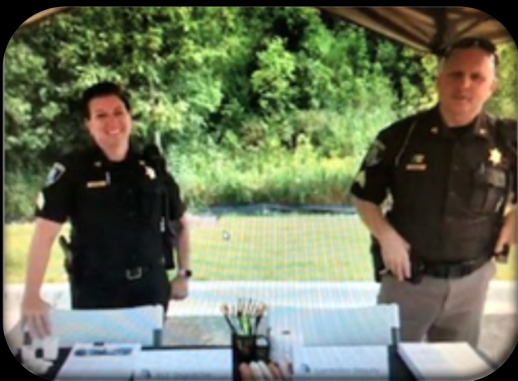

Training Division

The Training Division is responsible for all training of Macomb County Sheriff's Office officers and support staff. This includes new hires, promotions, and record tracking required by the state. In addition, the Training Division is responsible for recruitment and facilitating presentations and jail tours to various community groups.



In 2017, 13 in-service training days were conducted covering all three shifts. In total, 46,000 hours of agency training were completed. All MCOLES, MSCTC, and PSAP requirements were met for all officers.

Some of the top Training Division accomplishments for 2017 included training and equipping 153 officers with Narcan. MCSO achieved Bronze status award through the Michigan Veterans Affairs Agency for the hiring and retaining Veterans. A course in Emergency Vehicle Operation training and an Evidence Technician school were both developed and launched. The Macomb County Sheriff's Office also hosted a three day Tactical Medical Instructor course.

The Training Division attended 24 recruitment events off site at various venues and held three recruitment events at the Macomb County Sheriff's Office.

Sheriff Wickersham continues to support citizens of Macomb County with the opportunity to have job shadowing education opportunities. A youth academy for Macomb County high school students was held and every high school in the county was invited to send students interested in careers in law enforcement. Two senior academies were conducted for over 200 seniors in Macomb County. The four-week series of classes were to educate seniors about the operations of the Macomb County Sheriff's Office and its different divisions.

38 - Officers completed the Corrections Academy.

46 - Officers completed the corrections training program.

22 - Officers completed the Macomb Police Academy.

25 - Deputies completed the road patrol field training program.

8 - Command officers completed the command officer training program.

Firearms Training Division

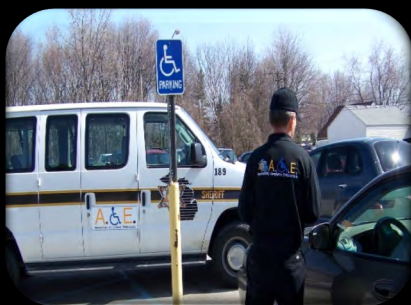
The Firearms Division of the Sheriff's office provides training in lethal and less lethal force options in 2017. Training and weapon qualifications were completed for over 650 people on our range, some on as many as four weapon systems. The Firearms Division conducted CPL classes for corrections and clerical staff, conducted Active Shooter training and assisted in other departmental training.



One of the largest projects completed during 2017 was the grant purchase, install and training with our new TI Labs Video Training Simulator. This equipment allows video training scenarios to better train deputies in use of force, judgement, and physical skills.



Reserves Units



Reserve Units



Community involvement is one of the key missions of the Sheriff's Office, and that is no more evident than with the Reserve Units. There are eight distinct units: A.C.E., ATV, Aviation, Cyber Crimes, Marine, Mountain Bike, Mounted, and Motorcycle. Members of each unit volunteer their time and their own equipment to assist the Sheriff's Office. Two other volunteer groups who donate their time to serve the citizens of Macomb County are Senior Volunteers and Explorers.

The 24,308 hours the reserves and volunteers donated in 2017 is equivalent to \$738,129 in funding for the county.

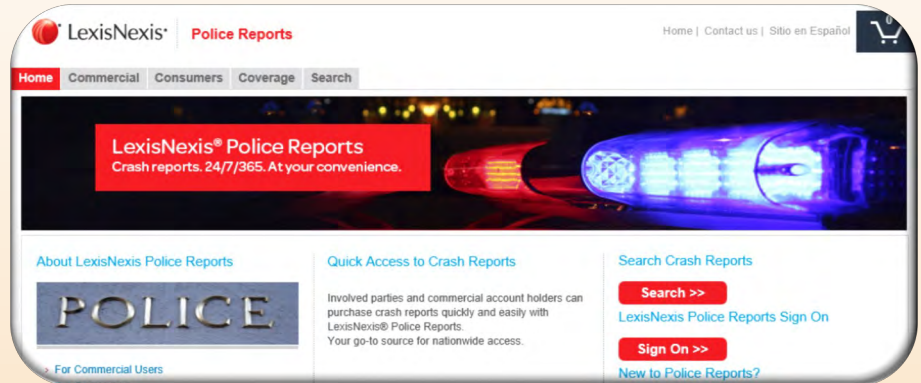

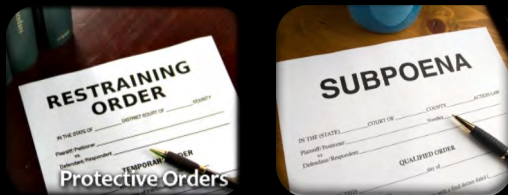
Civil Division
