




In the month of April, 62 incoming requests regarding traffic signals were received.

### Service Request by Dept.




In the month of April, TOC engineers closed 27 service requests within an average of 5 business days.

### **TOC** by Time of Day




### **Service Request Per Day of Week**






The map above represents the CCTV camera operational percentages for the month of April 2021.





### **SERVICE REQUESTS PER MUNICIPALITY**



### **GOVDELIVERY NOTIFICATIONS**

In the month of April, the TOC sent out 06 GovDelivery notifications, and increased the number of recipients from 2,491 to 2,554 receiving notifications.

Note: The chart below only shows data for the days GovDelivery notifications were sent from the TOC.



GovDelivery is a tool to notify Macomb County motorists of any incident blocking at least one lane of traffic or causing traffic issues. The notifications are sent after an incident has been verified.



Sign up for incident notifications on weekdays from 6 a.m. to 6 p.m. causing lane or roadway closures on major Macomb County arterials.
