

MONTHLY TOC HIGHLIGHT

In July 2021, the Macomb County Department of Roads Traffic Operations Center (TOC) engineers assisted the traffic flow for multiple special events at various parts of the County. One of which was the Shelby Township's Independence Day Fireworks. The show attracted many in-person viewers. The event started at dusk, around 10 PM, on July 1st and lasted for half an hour. After the event, the traffic took about 40 minutes to egress out of the designated parking lots. The TOC engineers monitored and deployed signals timing changes in real-time to nine signalized intersections based on traffic demand during that period. While police were on-site at the congested intersections, they monitored traffic operations rather than needing to stand in the middle of the intersection and direct active traffic, allowing motorists to utilize the traffic signals as intended. The TOC was able to effectively move traffic without additional risk to on-site law enforcement.







TOC by Time of Day











SERVICE REQUESTS PER MUNICIPALITY





GOVDELIVERY NOTIFICATIONS

In the month of July, the TOC sent out 63 GovDelivery notifications, and increased the number of 2,661,2,716

recipients from 2,661 to 2,716 receiving notifications.
