

Naturalization and Citizenship Assistance in Michigan

Benefits of citizenship

Civic: voting and running for elected office **Employment**: eligibility for federal jobs

Public benefits:

- Medicare requires higher premiums for non-citizens
- · Supplemental Security Income (SSI) if disabled

Social Security:

- · Retirement benefits available abroad
- · Survivor's benefits available if married to citizen

Family: ability to petition for more members

Security: protection from deportation

Financial: children may automatically derive citizenship

Travel: no limitations on the length of travels

Requirements for naturalization

- (1) Be 18 years or older
- (2) Be a permanent resident for five years (unless married to and living with citizen spouse for three full years)
- (3) Residency requirements: Continuous residence: primary residence is in the United States during the statutory period (e.g. house, bills, etc)
 - Physical presence: spend more time inside than outside the United States during statutory period
 - · Reside in Michigan for three months
- (4) Be a person of good moral character
- (5) Be comfortable writing, reading, speaking, and understanding English. Fluency not required. Exemptions available for older, long-time permanent residents and those with disabilities.
- (6) Demonstrate knowledge of U.S. history and civics
- (7) Be willing to take Oath of Allegiance
- (8) Pay the \$725 filing fee or qualify for a fee waiver*
 - * full and partial fee waivers available for households that earn less than 200% of the federal poverty guidelines
