### Public Safety Initiative: Stopping Violence in Schools

The Macomb County Prosecutor's Office has created an educational tool directed toward educating students and parents in conjunction with the "Knocking Violence out of My School" video competition.

The deadline for video submissions for "Knocking Violence Out of my school" is Friday, February 17, 2023, by 5pm. Macomb County middle school and high school students can submit a video (less than 2 minutes) to dawn.fraylick@macombgov.org for a chance to win big cash prizes by February 17, 2023. The first place is \$1,000, the second place is \$750, and the third place is \$500. The "Stopping Violence in Schools: What Parents and Students Need to Know" pamphlet is full of information including charges juveniles could face if they threaten a school, consequences for juvenile crimes, and results of having juvenile criminal charges even without a conviction. It also gives students and parents information on how to report a threat, violence, weapons, or bullying in school, how to keep your school and peers safe, and resources parents can turn to if they need help with their child. The Macomb County Juvenile Justice Center (JJC) is also featured with photos of the sleeping quarters and recreation room to show juveniles the living conditions in the JJC.

- Held in the Juvenile Detention Center
- Juvenile Diversion Program
- Community Service
- Driver's License Sanctions

- Out of State Home Placement
- Fines and Costs
- Confiscation of Phone
- · Deleted from Social Media
- No contact with your friends

#### Results of Having Juvenile Criminal Charges Even Without Conviction:

- Difficulty Obtaining Employment
- Trouble Joining the Military
- Hard to get accepted to College
- No Financial Aid
- Legal Financial Obligations
- Limited Housing Options
- No Public Benefits
- Enhanced Penalty for Future Crimes
- No Firearm Privileges as an Adult
- Deportation

## Charges You Could Face if You Threaten a School:

- Communicating a threat of terrorism MLC
- 750.543m a 20-year felony
- Calling in a bomb threat MCL 750.411a (3) (a) 4 year felony
- Threatening violence against the school, employee, or student MCL 750.235b (1) a
- 1-year misdemeanor
- Malicious use of a phone or computer MCL 750.540e a 6-month misdemeanor


