Detroit woman arraigned on 9 counts from behavior during traffic stop

Mount Clemens, MI - Yesterday, a 35 year old Detroit woman was arraigned in connection with a traffic stop and her alleged behavior following the traffic violation.

It is alleged that on Saturday, November 4, 2023, Fraser Police Department Officers attempted a traffic stop on Monique Darnita–Marie Moses for an expired license plate. Moses allegedly refused all of the officers' demands, put her vehicle in reverse and struck a police car, just missing officers. Moses fled, exited her vehicle, and resisted officers attempting to arrest her. Moses was taken to the hospital and while at the hospital Moses allegedly assaulted two officers, causing significant injuries including tearing an officer's hair out.

"This shows the dangers our police face daily, even if what initially seems routine. We must emphasize the importance of cooperation during encounters with law enforcement. Resisting arrest and assaulting police officers not only endangers the individual involved but poses a potential threat to the safety of our community," said Macomb County Prosecutor Peter J. Lucido.

Monique Darnita-Marie Moses is charged with:

Count 1: Police Officer – Fleeing in the 3rd Degree (five year felony) Count 2: Assault with a Dangerous Weapon (four year felony) Count 3: Police Officer – Assaulting/Resisting/Obstructing Causing Injury (four year felony) Counts 4, 5, 6: Police Officer – Assaulting/Resisting/Obstructing (two year felony) Count 7: Malicious Destruction of Fire of Police Property (four year felony) Count 8: Motor Vehicle – Operation without Security (one year misdemeanor) Count 9: Operating – License Suspended/Revoked/Denied (93-day misdemeanor)

Moses was arraigned today in 39th Roseville District Court by Judge Kathleen Tocco where bond was set at \$100,000 cash/surety only. Upon release the defendant is to not leave the state, wear a GPS tether, not leave home after 8pm, have no drugs or alcohol and no contact with Fraser Police Department except to report an emergency. A probable cause conference is scheduled for Wednesday, November 15, 2023 at 8:30am and a preliminary exam is scheduled for Wednesday, November 22, 2023 at 8:30am in front of District Court Judge Joseph Boedeker.

The Macomb County Prosecutor's office represents the people. We are committed to achieving justice and following the laws of the State of Michigan. All that are accused of a crime are presumed innocent until proven guilty in a court of law.
