Need to understand current Service Agreement a little better. Concerns from Jennifer Miller on the S.A. as far as the AIA expectations and the fulfillment of them by the DIA. Julie McFarland responded on behalf of the DIA. 2020 unusual year, fortunate that they collaborated and put together the Letter of Agreement. Recognizing the activities that generated funding fell short. The door is not closed on 2020 and hopefully moving forward will learn from these experiences. They would like the opportunity to take it back to the team to process and come back with real examples as to what applies and what doesn't. Rob Bowen added that he fully supports Julie and Jennifer's comments and brought forth his thoughts. The DIA will have further discussion to make sure they are aligned in 2021. Ed Bruley indicated we need to spell out more clearly what the AIA and the DIA expect from each other. Need to collaborate more clearly. An application process will be followed for prioritizing participating communities. Four communities have been contacted. A conversation is needed as to which ones make sense to proceed with. Motion made to have Utica and Macomb Township in 2021 and expediting process so no further discussion will be had in 2021 until a process that has been formalized by the DIA and AIA has been issued for 2022.
